Chair Taniguchi and members of the Senate Committee on Judiciary and Labor.

I appear before you in strong support for the confirmation of the nomination of Darwin L.D. Ching as the Director of the State of Hawaii Department of Labor & Industrial Relations (DLIR).

In my view, based on my experience as the Director of the Department of Business, Economic Development, and Tourism (DBEDT), there is no more important issue impacting Hawaii citizens' future quality of life than workforce development.

We all know Hawaii's low unemployment rate and the difficulty of employers to find employees. To remedy this structural problem, importation of workers or in-migration is not an

effective solution. We need to increase workforce participation, including re-training and reentering into the workforce those who have "given-up" or who are chronically unemployed.

We also know that employers are having difficulty finding staff with the right level of skills. Skill-sets and the requirement of the jobs of the 21st Century are evolving more rapidly than ever before, driven by fast- changing technologies, technological and operational processes.

Mr. Ching has the commitment, background and experience to lead the DLIR to meet these workforce challenges.

What is notable about Mr. Ching's qualifications for the DLIR Director position is that he brings together an educator's and a labor law practitioner's experience and perspective. I believe this is a rare combination and a very necessary one. Hawaii's workforce development policies need to be driven by both the K-12 and the incumbent workforce. Mr. Ching brings both to the position.

In my extensive interactions with Mr. Ching over the past 3 months, I have been very impressed with his energy, focus and collaborative approach. Immediately following his interim appointment, Mr. Ching sought me out to discuss how workforce development policy and economic development policy needed to be more integrated. We have had many subsequent discussions on these policy matters and I am very confident that intra-departmental cooperation on workforce will be very strong and productive under Mr. Ching's leadership

I would like to take this opportunity to write in strong support for the confirmation of Darwin Ching, the gubernatorial nominee, as the Director of the State Department of Labor and Industrial Relations.

I have been a state employee for 41 years and it has all been in the Department of Labor and Industrial Relations. This is my thirteenth year in my current position as the Administrator of the Workforce Development Division. Interim Director Ching is the twelfth Labor Director that I have had the opportunity to work with. Directors come to the department with different and various leadership styles, temperament, agendas, strategic plans, visions, goals, objectives and priorities because they sincerely believe that they are going to be the one to make changes to make the department better. As a career civil service employee, I have had the opportunity, especially within the last twenty years to work very closely with the Directors and their immediate office staff.

Interim Director Ching began working for the department in early August 2007, approximately eleven weeks ago. During that brief period, I have observed several positive characteristics that have impressed my staff and me. He is sincerely interested in all staff and their concerns and has expressed this in his meetings with all DLIR staff statewide. He is a good listener and communicator. listens, absorbs the information, participates actively in the discussions and has even made decisions to resolve the issue(s) by the end of the meeting. Incidentally, he strongly believes that productive meetings are usually no more than one hour long which definitely promotes my personal philosophy of "no wasting of time".

In his introductory address to DLIR employees he has repeatedly expressed that he is team oriented and a team player. From the very beginning he expressed to DLIR's Administrators and Office heads that he would be depending on them to assist him because he felt that they were the experts in their programs areas. He said he would be consulting a lot with us and he has been practicing that daily. I find that refreshing and invigorating.

It is probably due to his professional education and attorney background that he is curious and a quick learner. He has already shown his ability to make decisions when provided all the available facts and because of this, approval and processing of documents by his office has been improved.

One very important goal that he has expressed is to build the capacity of the incumbent DLIR staff so that they will be equipped to do their jobs better and to be prepared to move up to higher positions within the department in the immediate future. This has definitely improved staff morale in my division. Being action oriented, he has a team working on providing an initial staff training course before December 31, 2007.

Director Ching sincerely has tremendous energy and a compassionate heart. I feel that based on what he has expressed as his priorities and what he has done in the brief period at the department, he will do well as the next Director of Labor and Industrial Relations.

TESTIMONY STRONGLY AGAINST THE APPOINTMENT OF DARWIN CHING:

I am a private citizen, mother of four children and a member of the Children's Rights Council of Hawai'i. My children and I have suffered much pain at the hand of Attorney Darwin Ching. He served as Hawai'i Family Court Defense Counsel; representing his <u>cousin</u>, Defendant Kevin Chee (another Honolulu attorney), in post-Custody divorce issues. As Defense Counsel, Darwin Ching maliciously used his influence as "Good Friend of the Court" [See Ho'Ohiki Case # 1DV9501599, Court Minutes Date Feb. 04, 2004] to perpetuate defective, unconstitutional court actions in the Chee v Chee case.

Although Darwin Ching does not have a Family Law practice, he leveraged the Family Court to run roughshod over Plaintiff Melinda Chee and the 4 children of the Chee marriage. His actions represent the epitome of domestic cruelty!

There is a long line of unhappy Hawai'i Family Court customers. Systemic problems in the Hawaii Family court are widely recognized. Attorney Darwin Ching hobnobs with the Hawai'i Family Court, performing backstage actions under the cloak of his primary law practice.

The Hawai'i Legislature has been holding Special Hearings in both the Senate and House to investigate the abuses of legal interventions employed by the Family Court. Hawai'i Family Court Chief Judge Frances Q.F. Wong turns a deaf ear to the problems and blithely refers to the most unjust cases as "red herrings". Shocking issues involving the Hawai'i Family Court were uncovered in a 2002 audit of the Hawai'i Family Court, which the Hawai'i Family Court has

You are probably aware of an Article in the Hawai'i Bar Journal, February, 2004 titled *"Divorce Law in Hawai'i: An Update"*, by eminent Hawai'i Family Law attorney, William C. Darrah. He states: "The situation has become SO BAD [emphasis added] that lawyers resort to presentation devices which in fact violate the Hawaii Rules of Evidence. (See Kie v McMahel, 91 Haw.438, 984 p.2d 1264 (App 1999).

Unhappy Hawai'i Family Court customers are becoming increasingly frustrated by Judge Frances QF Wong's failure to recognize and correct the unjust and unconstitutional processes of the Hawai'i Family Court.

It is time for a change!! There have been many **BROKEN PROMISES** to the people of Hawai'i. Promoting Hawai'i "Family Law" Attorney Darwin Ching to the long term position of Director of the Department of Labor and Industrial Relations assures ongoing corruption and practices profoundly odious. I am a physician who has been a member of the Prepaid Health Care Advisory Council of the State of Hawaii since my appointment in 1990 by Governor John Waihee. During that seventeen-year tenure, I have been proud to serve under a number of Directors of this Department.

While other Directors have taken the time to attend some of our monthly meetings, I have been impressed with Mr. Ching's approach to our meetings. Like the other new Directors, Mr. Ching attended the first two meetings of the Council since his appointment as Director of the Department. However, after the second meeting, Mr. Ching announced his intentions to approach his new responsibilities with some of the characteristics of his background as an Educator. The Hawaii Civil Rights Commission (HCRC) has enforcement jurisdiction over Hawaii's laws prohibiting discrimination in employment, housing, public accommodations, and access to State and State-funded services. The HCRC carries out the Hawaii constitutional mandate that no persons shall be discriminated against in the exercise of their civil rights. Art. I, Sect. 5.

The HCRC supports the confirmation of Darwin L.D. Ching for Director of Labor and Industrial Relations. The HCRC is attached to the DLIR for administrative purposes. Mr. Ching has served as the Director of Labor since Governor Lingle appointed him in August 2007, pending confirmation. As such, the HCRC Executive Director and staff have had the opportunity to work directly with Mr. Ching on a wide range of administration activities that fall within his day to day responsibilities, as well as to engage in policy discussions on labor and civil rights issues. Judge Randall Lee has been a mock trial coach for a year now and I was privileged enough to have his as my coach. He brought with him vast knowledge of the law and a deep understanding of it as well. It is a privilege and pleasure to offer my statement supporting the gubernatorial nomination of Randal K. O. Lee to the position of Associate Judge for our state's Intermediate Court of Appeals ("ICA").
