It is my pleasure to write a recommendation for Ms. Anne Marie Beck, as a nominee to the Hawaii Public Housing Authority Board. I have known Anne Marie in both a personal and professional capacity for over four years and believe I am a good judge of her qualifications and accomplishments.

Anne Marie is passionate about the organization that she leads. Since I first began volunteering at the Honolulu Habitat for Humanity (HHH), she has shown nothing but dedication to the cause. She is extremely good at showing her appreciation to staff and volunteers and they enjoy working with her.

I believe that Ms. Beck has improved many areas of the HHH and I am listing some examples below:

She has reduced the mortgage delinquencies that many homeowners had in place when she was hired; she did this by forming relationships with the homeowners and helping them to see the value of paying their debts and increasing the equity in their home.

She has increased public awareness of the organization with various public appearances, newspaper articles, and personal involvement with business and other non-profit organizations that complement the housing cause.

She has put formal programs in place, for instance, the Family Selection Committee now uses a consistent process to help families apply and strive to be selected for a home. I have served on this particular Committee and know that the changes she has put in place have been effective.

Anne Marie has implemented a variety of new fundraising ideas over the last few years. During the annual holiday fund drive, her staff produces a Christmas Catalog, which allows donors to pledge their donation towards a house-building item, such as a toilet, or a bucket of nails, for example. In the summer, the HIHH now has a Build-A-Thon during which teams of volunteers get pledges and work on building a house. Just recently, we had the inaugural 'Martini Madness' event, a new fundraiser that has a silent auction and reception for supporters.

Serving on the Board of Directors since 2006, I know that Anne Marie is striving to enhance her management skills and her community involvement so that she might take the HHH organization to the next level. The organization has a goal to start two homes on Lanai and at least four to six homes on Oahu in 2008, all of which will require training site supervisors and volunteers, building strong relationships on Oahu and the outer islands, and meeting the needs of the community. I can't help but feel that Anne Marie's anticipated contributions on the Hawaii Public Housing Authority Board will both further the goals of the Honolulu Habitat for Humanity and the people of Hawaii.

Anne Marie has my support for this nomination, and I encourage you to confirm her in this position.
