Regarding appointment of Sherilee Dodson to Board of Directors of Hawaii Public Housing Hearing at 1:15 tues. Oct. 23, 2007.

In my 30 years as a professional in the construction industry I have never met anyone so incompetent and ill-qualified in the area of housing as Ms. Dodson. Her only qualification to be chosen for the director of Habitat for Humanity was she worked hard for the Lingle election campaign. Looking at the board of Directors for Oahu's Habitat, it is similarly packed with loyal Republican party workers.

As habitat director, Ms. Dodson had no idea how to build houses and refused to listen to the advice of any of her more qualified board of directors or hired construction supervisors. She made brash claims about how cheaply she could build a house without ever establishing a budget. Her "bookeeping" is in such chaos, she has no idea how much the houses cost. No accountability whatsoever.

Her most damning flaw however is her condescending and abusive attitude towards the recipient families of Habitat's homes. She has no understanding of the issues and dynamics of the plight of the poor people the program was designed to help. And she has even less regard for Hawaiin culture, a major disqualification since the majority of recipients are in Hawaiian homelands. She talks over and around the people getting the homes and threatens them with disqualification if they question her unilateral and capricious decisions. If you could interview any of the homeowners in the program ,the list would be endless with complaints about their treatment under her, but not one will speak to the press or any government agency for fear of losing their house thru her vindictiveness.

Public Housing agencies need strong advocates for the poor and to implement programs that actually create housing, not just study it. Ms. Dodson is not that person and never will be. If the Lingle administration's goal is to pack the board with people who philosophically disagree with social programs that spend tax money helping the poor, and wants people who will drag their feet and slow down programs that are practically dead anyway, Ms. Dodson fits that profile.

Dear Senator Chun Oakland,

Thank you for the opportunity to address the Committee on October 23, 2007, regarding my confirmation to the Hawaii Public Housing Authority. This is my first experience being confirmed to a Board so I did not know what to expect. I wanted to thank you for your kindness which made the experience less stressful and actually enjoyable.

I am not sure if it is appropriate to address the one negative letter against my confirmation but as I indicated at the hearing I really didn't have much recollection of the circumstances surrounding some of the accusations made by the letter writer. After some reflection and reviewing the office files I do now have more information about who the letter writer is and his relationship to Habitat for Humanity Maui.

As I indicated at the hearing, Mr. Hall was contracted as a Project Manager for one of the first two houses built in 2003. He began project managing for us in July of 2003 and his contract was terminated in December of 2003. I don't feel it necessary to give any detail about the circumstances that resulted in us terminating his contract except to say that I did have full support of my Board of Directors at the time to terminate the contact.

It is unfortunate that Mr. Hall is still quite angry about the situation and I won't address his personal attacks to me, but I do feel strongly that the allegations about Habitat for Humanity Maui need to be addressed. Habitat for Humanity Maui was incorporated in 1997 and spent the three years building up support for the organization. It began a renovation in 2000 and spent the next several years doing renovations on a couple of houses. In 2003 they hired me as their first Executive Director as they had planned to start their first full build on Hawaiian Home Lands in Kula.

At the time I was just coming off a period of disability from my second kidney transplant and had wanted a career change. I answered an ad in the paper and was interviewed along with several other candidates. I was not chosen as director because of any affiliation with the Lingle election campaign. My understanding was that I was hired by the Board of Directors because of my resume and my knowledge of the construction industry.

My job description was and is to manage the day to day activities of Habitat and to carry out the vision of the Board of Directors. On behalf of our very competent Board of Directors, the highly qualified staff and the over 2,500 volunteers that now work with Habitat for Humanity Maui, we are very proud of our contribution to the Hawaiian community and the community at large.

Habitat for Humanity Maui has partnered with many agencies on projects to help the community. HfHM with the help of Nortel Company volunteers renovated the Central Boys and Girls Club building. The Maui Rotary Clubs partnered with Habitat to renovate units at the public housing project in Happy Valley. Habitat also offers discounted or free building materials to all the non-profit agencies on Maui and Molokai.

Habitat has built 15 homes since that first day in 2003. Currently Habitat is building 14 homes and designing a 40 unit condominium building for Wailuku. Habitat has a great reputation in this community because of its Board, staff and volunteers. We hope that your opinion of this organization is not tainted by one person's opinion.

I will be glad to answer any specific questions that you or the Committee may have. I am proud to be associated with this organization and proud of what we have accomplished in the last four years in this community.

I am excited about the opportunity to serve on the Hawaii Public Housing Authority Board of Directors. I feel it is a great honor and hope to bring the perspective of an outer islander as well as a non-profit developer to the Board.
