My name is Wade Lord and I strongly support Hawaii Superferry. I am a resident of Kauai and have watched with interest and a certain amount of sadness as this saga has played out publically. I support the Superferry based on the following rationale: 1) It proceeded with an investment of enormous scale in good faith based upon a prior court ruling and with State DOT assurances. 2) Never before has an EIS been required for harbor users. I don't have a problem with the requirement as I'm confident that the findings will be favorable, especially in comparison to current harbor users such as cruise ships, barges, and military vessels. What bothers me is the timing. This should have been required long before the maiden voyage. It's patently unfair for the requirement to come after the fact. 3) Whale avoidance measures are much greater than those found on other commercial vessels. In fact, friends that live in Juneau Alaska are mystified by this argument, as they currently have three high speed ferries servicing their coastal communities for several years, without incident. The waters around Juneau and surrounding communities in Alaska are home to the humpback whales, killer whales, etc. 4) Concerns about traffic impacts are not based in analysis. The total number of added cars to any one island between voyages is negligible as a percentage of the total resident cars of a given island. Numbers bandied about do not factor in the net difference of cars leaving a particular island on each voyage. 5) With no program to inspect other interisland barge and ship service from unintentionally carrying pests between islands, it is unfair to single out the Superferry for additional requirements beyond the inspections systems that they have already put in place, which I am guessing are greater than any other commercial harbor user. In an effort to keep this testimony concise, I will stop here and I request that you look favorably and fairly upon this entity as it relates to the above noted house bill.
