My name is Henrietta Yee and I strongly support Hawaii Superferry.

I can't testify in person, however I strongly support letting the HSF run. We need more and diverse ways to travel around the state. It will benefit the economy and enable disabled persons an easier way to go interisland. They have a very difficult time with air travel (wheelchairs, oxygen, and other special medical items are bulky.) I have lived here for 28 years, but grew up on Cape Cod, where ferries that transport cars are a big part of travel to and from Boston, Nantucket, and Martha's Vineyard. They now have what they call the Fast Ferry from Provincetown to Boston. It goes about the same speed as the HSF, and runs through a whale breeding and feeding ground with Humpback, Sperm, and Right whales. A whale protection group conducted a 5 year study on collision mitigation on that ferry and found (with observers like the HSF will have) NOT ONE COLLISION occurred during the 5 year study!
