We support the Superferry for the Hawaiian Islands for the following reasons:

- 1. It will provide an alternative to flying which is the only current option as a way to get between islands.
- 2. It will allow local businesses to move produce and other vital services (like home contactors) between islands in a more economical way.
- 3. It will allow residents a more convenient way to travel inter-island with their own vehicles visiting family and also, making one able to shop on Oahu and thereby have access to more services/businesses than on the other islands.
- 4. It will allow tourists an opportunity to explore the islands, providing a richer cultural experience and more economic activity for local businesses.
- 5. In the event of an emergency, local governments would have access to a much needed resource to more easily move disaster equipment, supplies and personnel.
- 6. The environmental concerns are understandable, however, one trip per day to each island is a small amount of boat traffic, compared to all the power boats, sailboats and passenger liners that are constantly plying the Hawaiian waters and yet no Environmental Report is required for any of that traffic. Whales are important no question, but again, that a trip 3 times a day between islands can impact them that much more than all the other boats in the water seems a bit thin for a plausible argument.
- 7. During peak hours, off loading of cars and trucks will probably congest the roads more proper traffic management is required to ensure locals will not be inconvenienced in their daily commutes. (Why is the Maui ferry off loading in Lahaina rather than Maalaea Bay a better drop-off point for access in Maui?)

In Washington and other states in our country, ferries have been plying the waters for many, many years with very little negative impact on their communities and a much more positive benefit to local residents, businesses and tourists. Thank you for allowing the opportunity to submit written testimony regarding legislation which would permit operation of the Hawaii Superferry while environmental issues are addressed. We will not be testifying in-person.

My wife and I own two properties on the Big Island. We urge the Hawaii State Legislature to identify a solution that would enable Hawaii Superferry to continue operation while an environmental assessment is being conducted. Frankly we are perplexed that, after the Superferry commenced operation and after tens of millions of dollars in state and private funds have been expended, questions about environmental compatibility are still at issue.

The nature and motivation of the Hawaii state courts' recent actions effectively rendering the Superferry dead in the water are questionable at best considering the seemingly disparate requirements imposed on other inter-island transporters. The 11th hour timing of these decisions makes them even more suspect given that years have passed by since the announcement of the development of the Superferry. These decisions do little to counter the notion that Hawaii is a provincial place when it comes to doing business.

The people of Hawaii, including those of us who consider Hawaii our second home, want inter-island transportation choices. Hawaii Superferry is a transportation alternative which will bring benefits to full and part time residents and to the businesses of Hawaii. Please don't let this alternative be cast away.

The questionable timing of the decisions affecting the Superferry service shouldn't be allowed to now deprive the islands of this valuable transportation alternative. My name is Cyrus B. Hall and I strongly support Hawaii Superferry.

It is time Hawaii have an alternative to interisland transportation. While the Airline industry, notably Hawaiian Air and Aloha Airlines have served up interisland transportation over nearly the last 3/4ths of a century, they have also limited and lowered expectations with regard to transportation among the islands. On the mainland, to visit friends or relatives, I might load up my car, board a train, or get on board an aircraft. Here, I must use essentially Hawaiian or Aloha, wait at the airport, and finally board and sit in uncomfortably small chairs. Once at my destination, I then go to the car rental office for ground transportation. With the Superferry, I now load up my car and drive to the ferry, enjoy a leisurely trip in comfortable surroundings, and then, at my destination, drive to my final destination.

Of course you know all that. The Superferry is so reasonable I have a hard time understanding why there is any opposition at all.

Firstly, understand that the EIS is merely a ploy to keep the Superferry docked until there is no choice but bankruptcy. The timing of the opposition makes this obvious. There is no real concern for the environment from the opposition. There is no real concern for security from the opposition. There is no real concern for potential criminal activity for the opposition. There is real concern from the opposition for change, any change. Change can bring about the unknown, and the unknown is frightening to many. The same arguments were used to keep K-Mart out of the islands for years as well, and none of the predicted disasters has befallen our islands.

The ferry uses the same sea lanes as Young Brothers, the cruise liners, the military, by international and by national shipping resources. What is the additional environmental impact that should keep the ferry from sailing and the rest doing business as usual? To force the Superferry to cease operations until the environmental impact is studied without also requiring the other users of the sea lanes to do the same is patently unfair and discriminatory.

The ferry brings over cars. The "issue" that this will increase the number of cars on the neighbor islands is bogus as most will add a car anyway because of the need for ground transportation and rental cars as well.
