To Whom it may concern: The following are my comments RE: the SF.

# **Super Ferry**

A common concern amongst many of the individuals who either oppose the Super Ferry (SF) or who insist an EIS/EA be completed prior to the SF operating is the possibility of irreparable damages which may occur to the environment. They fear that things such as opihi, fish, maile, palapalae, river pohaku, wild game and other resources will be plundered and depleted. Truth be told, these resources are being plundered and depleted long before the SF was even a topic of discussion. Attempts to establish meaningful resource management has historically been meet with opposition. Resource management options such as fishing licenses, catch/bag/take limits, seasonal closures, allowing the sale of wild game, prohibiting the sale of near-shore species have been shouted down by some of the same people bemoaning the rape of "their" resources by "Oahuans." if the SF is allowed to operate. If good and reasonable resource management, together with clear concise enforceable rules and sufficient enforcement of these rules were already in place, it would matter who or how many users visit the other Hawaiian Islands using the SF. I

# It is not the SF fault that we do not already have such resource management in place.

Another concern of those insisting on an EIS prior to SF operation is that passengers and their vehicles will overwhelm the neighbor islands infrastructure. The truth is that neighbor islands infrastructure is already overwhelmed and inadequate. Local government has been stymied in developing much needed infrastructure by some of the same people who oppose the SF. Environmental review and cultural sensitivity are a few of the reasons cited to stop highways, bypasses, waste water treatment plants, landfills and affordable housing in close proximity to jobs. Subdivisions and gated communities come out to say, "Not in my backyard!", when plans to connect or allow traffic to flow through their neighborhoods are proposed. Having these connecting roads would allow the flow to continue to move at high traffic times, when power lines fall across highways, when bad accidents occur or when a natural disaster strikes. Our inability to come together and agree on solutions has left our local governments impotent in providing the very infrastructure we demand. It is not the SF fault that State and Local governments have not been able to adequately address neighbor island infrastructure problems.

The SF received Executive permission, via the Dept of Transportation, to proceed with its plans when an exemption to environmental review was given.

The SF received Legislative permission to proceed with its plans when funding was sought received and disbursed for port improvements.

The SF received Judicial permission to proceed with its plans when both a US District and lower court dismissed lawsuits against the SF and effectively upheld the DOT environmental review exemption.

Finally, I have discussed the SF with several individuals who vehemently oppose the SF for varying reasons. I presented them with a "What if". What if all your concerns for the environment, infrastructure and culture were adequately addressed? What if each and every vehicle were checked bumper to bumper, power washed, inspected for invasive species, checked for poached game, searched for drugs, firearms, stolen goods, etc ... What if roads near the harbors were improved and vehicles only allowed to leave the SF two at a time every ten minutes or so? What if every SF passenger were taught to be culturally sensitive and aware both before setting sail and whilst in transit?

The answer I get is, '"If the SF did all that, they wouldn't be able to continue doing business in Hawaii." or something to that effect.

To which I say, "Precisely."
