My name is Frederic Berg and I strongly support Hawaii Superferry.

I find it unfortunate that our Supreme Court had to support opponents of the Superferry by creating a new precedent rather than ruling in line with previous precedent, however that is how our democracy works, therefore we now need to make the necessary changes in the Legislature to allow the will of the people to prevail. (My understanding is that 60 - 90% of the people of the State of Hawaii want to see the Superferry operate and most do not want to wait for an EIS process either for philosophical reasons or for fear of loosing the Superferry because of its financial obligations during this extended period with no revenue.)

The Superferry brings infrastructure to our State that can help fuel internal economic activity, making us more resistant to external economic shocks, changes in the global economy and the negative results of economic pressures on large conglomerates.

I have sailed inter-island for the past 35 years and enjoy the whales visiting our islands more than most people. I see nothing wrong with the Superferry operating between the islands in much the same way a Matson container ship, Young Brothers barge or a Norwegian Cruise Line cruise ship currently operates in our state waters. Please keep in mind that the same Superferry attributes that give it its speed give it greater maneuverability to avoid whales.

As to concerns with invasive species, please keep in mind that any operating procedures not currently in force with existing carriers that may be imposed for Superferry operations, will likely be imposed equitably on all carriers over time. If passengers shoes and suit cases have to be inspected for mud and vegetative matter, this will hold true for passengers on airplanes as well as cruise ships. Vehicle inspections will have to be carried out on any vehicle transported inter island including on barge service. Delays caused by these inspections will have a negative impact on our inter island trade.

Please approve a fair bill that will allow the Superferry to resume operations with out delay.

My name is *Esmond Chung* and I strongly support Hawaii Superferry.

First of all, I'd like to thank you and your colleagues for the painstaking efforts you take on crafting bills and passing laws that shape the quality of life we all enjoy in Hawaii. It seems that a day doesn't go by without some issue being considered that is loaded with controversy and challenges from all corners of our community. I believe this is inevitably a good process for all but not necessarily for those of you mired in negotiations and the challenges of arriving at a "happy ending" for all parties involved. Of course, that will never happen but an agreeable compromise should be the desired intent of all.

That being said, I believe that all modes of transportation that operate inter-island, by air or sea, should be held to the same standard ie; inspections, EIS, etc. I believe the Superferry is being unfairly treated in this regard. Does NCL comply with all the criteria that is being put forth for the Superferry to operate? How about Young Brothers, Matson, or Sea Land, etc? For that matter, what about the inter-island airlines?

I remember all the controversy surrounding the building of the H-3 freeway. All legitimate concerns were addressed and in the end, the freeway was built. I think you would be

hard-pressed to find anyone who is not happy the H-3 is available and convenient for drivers to go back and forth to both sides of the Koolaus. I think the Superferry is being subjected to a similar kind of treatment that the H-3 freeway was forced to endure, however, with more restrictive criteria imposed on it.

I think allowing the Superferry to sail while an EIS is performed is the right thing to do at this point in time. Monday morning "quarterbacks" taking pot-shots at will do not help the process of arriving at an agreeable compromise. Should the Superferry not "pass" its "test", then it should not be granted approval to sail and perhaps another company sought who can comply. However, keeping the Superferry in chains dockside does not serve the common good of the majority of the citizens of Hawaii. It also reflects very poorly on doing business in Hawaii.

Let the Superferry sail, do the EIS, continue to negotiate with all factions where necessary, and let's move forward.

Attempting to make progress in Hawaii is a bittersweet challenge and one that will never go away, but one well-worth taking if we truly believe we are a viable "player" and destination in the global village.
