Attached you will find articles relating to the danger of hi speed ferries and whales. The Hawaii high speed Superferry is an accident waiting to happen, and we as a state are being asked to immediately bypass any real review before it goes into full service.

The Superferry HAS NOT answered in any way the catastrophic possibility of the same scenario happening here. They will simply be going too fast for a deckhand with binoculars to spot anything. I am a licensed professional mechanical engineer, with 6 years of service in the United States Navy, 4 of those years at sea. I know what I am stating.

Japanese ferry runs into 'whale'

A high-speed Japanese ferry has collided with what is thought to be a whale, leaving 49 people injured - 13 in a serious condition.

The two-deck ferry, carrying more than 100 passengers and crew, was near the city of Kagoshima on the southern island of Kyushu when it happened.



The Coast Guard said it received a distress call from the boat shortly after 1800 local time (0900 GMT).

Ships in the area often collide with whales, a ferry company spokesman said.

Seven of the most seriously injured passengers have been taken back to land by rescue boat, a coast guard official said.

He said the other passengers remained on the ferry, which was not in danger of sinking.

Ferry spokesman Yukinori Chosa said the impact caused many people to fall over and hit their backs.

The ferry is now unable to move on its own and will have to be towed back to port, he told the AFP news agency.

Officials believe the boat collided with a whale or another large sea animal.

KAGOSHIMA, Japan - More than 90 people were injured when a hydrofoil hit an unidentified marine object off Cape Sata on Sunday, a Japan Coast Guard spokesman said.

According to the 10th Regional Coast Guard Headquarters in Kagoshima, 88 of the 109 passengers and five of the six crew members on the high-speed ferry Toppy 4 were hurt. Of those, 12 were seriously injured. Thirty-six, including some crew members, were hospitalized.

Coast Guard officials started Monday morning inspecting the water around the accident site and are expected to question Koichi Akase, the ferry's captain, who was hospitalized.

According to a spokesman at Kagoshima Shosen, which operates the ferry, **Toppy was** cruising near its maximum speed of 50 mph at the time of the accident.

"Something hit the hydrofoil's port stern quarter, and the boat plunged forward," Akase was quoted by the spokesman as saying. "There was no driftwood in sight, so I think it's highly likely that Toppy hit some kind of marine creature like a whale."

The coast guard dispatched six patrol vessels and two helicopters after it received an emergency call from a passenger on board Toppy at about 6 p.m. Sunday. The 12 seriously injured people and infants were transferred from the ferry to two patrol boats. The two boats arrived in Ibusuki by 9:50 that evening.

The patrol ship Sendai towed Toppy, which was unable to continue under its own power, and the remaining 85 passengers on board reached Yamagawa Port in Ibusuki at 11:30 p.m.

Four Toppy ferries ply the route that connects Kagoshima, Tanegashima island and Yakushima island 13 times daily. Kagoshima Shosen began operating the service in 1989.

The ferry has a hydrofoil at its bow and stern that lift the boat's hull above the surface of the water. Though **the boat is equipped with an underwater speaker that emits a sound whales are supposed to dislike, it is not effective against all kinds of whales**.

NAGASAKI, -- High-speed hydrofoil ships ferrying passengers between Fukuoka and Busan, South Korea are increasingly running into whales near the Tsushima Strait -a problem some fear will put them out of business.

The operators of the ships are trying to pinpoint the exact cause of the accidents, but some experts say they may be unavoidable.

Some say the collisions are caused when whales rapidly surface from deep water; others say females raising calves can't avoid the fast-moving ships.

The international ferry service is jointly run by Kyushu Railway Co. (JR Kyushu) and South Korea's Miraejet Co. The companies make five round trips a day.

"Jetfoil" boats have hydrofoils mounted in the front and back that allow them to skim the waves at more than 80 kph as their hulls float 2 meters above the surface.

According to JR Kyushu, there have been six collisions involving jetfoils since December 2004 -- four this year alone.

In South Korea, about 30 people were injured when the Kobee, a high-speed boat, was apparently hit by a whale.

Tsutomu Tamura, head of the Ecosystem Section at the Institute of Cetacean Research, said beaked whales feed deep in the sea and may have failed to dodge the boats when they came to the surface for air.

Akira Takemura, a professor at the Faculty of Fisheries, Nagasaki University, said the frequency of collisions in the spring is something the companies should pay attention to.

"Spring is the time when humpback whales that have raised their calves in waters near Okinawa and Taiwan travel north through the Tsushima Strait," he said. "It is possible that humpback whales traveling with calves, which move relatively slowly, may have collided with the boats."

Aloha members of the House Committee on Transportation and Committee on Finance,

My name is Lynette Cruz. I teach at Hawaii Pacific University in the anthropology program. Every semester I take my students for a short walk to the State Capitol and try to give them a sense of how government works. We discuss problems of social justice and how government can help mediate and/or resolve social justice issues.

I'm trying to give them the idea that the people's voice makes a difference, and that government should be responsive to the people's voice. Otherwise, why bother to participate?

In class we've looked at the Superferry issue. On the face of it, it seems fairly clear in terms of resolution. The law provides a way for businesses and organizations to interact with government. Government acts on behalf of the people. The process is clear. But special interests seem to have the ability to sidestep that process. And then government, somehow, begins to act in the interest of businesses and/or organizations, despite what the people say they want. Government begins to make decisions despite the people, or as if it 'knows better', effectively silencing the voice that I, in my capacity as teacher, try to get my students to believe is paramount to running good, clean, effective government. I've been telling them that their 'voice' guarantees fairness, justice, and good government.

I think that if the legislators of this state stop listening to the people's voice, then perhaps it's time that I stop talking about people's empowerment through participation, and start talking about how it doesn't work, and why they shouldn't participate.

If legislators don't listen to the voice of the ordinary person, and the legal process doesn't work for us, then I'd best be shifting my approach and getting them ready to recognize that the democratic system is only as good as money, via big business and special interests, can buy.

Do the right thing. Stick to the process. Demand an EIS before the 'business end' kicks in. If you begin making exceptions now, when/where will it stop? And will the exceptions then become part of the 'process', effectively curtailing the people's power to have their voices heard? I hope not.

My business, Hawaiian Resources Co. Ltd., strongly supports the Superferry and all 15 of our employees agree that they support this alternative method of transportation.

An email has arrived from Young Brothers that will reinforce the point that business and individuals need alternative methods for moving cargo and automobiles between the islands.

Please read the attached announcement from Young Brothers. It announces that from now on, all cargo going to Kauai will only be received in by Young Brothers on two days of the week (Monday and Thursday) and for only three and a half hours per day. All cargo for Lanai can only be shipped on one different day of the week (Wednesday) and for only three hours of that day.

Have any of you ever sat in line to send interisland cargo out on Young Brothers? Do you realize how many hours of your day is wasted by sitting in these lines? Are you aware of the calibre of "service" that a customer receives when dealing with Young Brothers? By limiting the days and times, these lines will only be longer. So now if a shipper has cargo for Maui, Lanai and Kauai this means that we must go and sit in these lines on three different days of the week instead of making a drop off and standing in a Young Brothers line only one time for all islands. Look at the time wasted and the number of times a week that a shipper has to send trucks on to the roads and into traffic to sit in lines and deal only with Young Brothers.

Young Brothers desperately needs some competition for cargo between the islands for them to clean up their service act. Businesses in Hawaii desperately need some alternatives to dealing with Young Brothers. Interisland freight competition is desperately needed.

Please. please, please support the Superferry and set the parameters for her to sail profitably between the islands.

While I would love to be able to testify in support of the Superferry, I'm not able to travel to Oahu at this time. It has been my experience that those who attend the hearings can be very vocal and intimidating. I routinely attend zoning meetings; it is normally the same vocal minority with the same distracting testimony.

While none of us wishes to harm the environment, the time has passed to focus so completely on the environmental issues that no other issues matter. It's impossible to ignore the economic impact on the state and businesses who based their business plans on this important mode of transportation. The Superferry complied with all permitting and requirements that the state imposed. While I am happy for the double-checks created (albeit at the last minute) by those concerned with the environmental impact, it just at some point, protests have to sunset else we'd have protests over, for example, the use of combustion engines starting now. The Ferry relied on a promises and commitments made by our State government. For goodness sakes, the State should honor those commitments.

Because we have so many modes of interisland travel (including routine transportation of vehicles via barge) it seems silly to think that the Ferry could worsen impact related to vehicle transportation and invasive species. The increase in vehicle load on the roadways should be off-set by a reduction in rental cars. Invasive species travel in luggage, purses, in containers and the like. Hence, the only additional impact seems to be related to speed. The Superferry should not be subjected to stricter controls than other forms of sea-bound transportation. Limiting their ability to run does exactly that. Because the speed issue seems to be the only issue differentiating the ferry from barges and cruise ships, the focus should be on allowing the ferry to operate and determining at what speeds they can safely operate in the presence of whales, which at best is a seasonal consideration.

It seems blatantly unfair that the Superferry be singled out at the 11th hour. This state is bound together by water. In fact, the single thing that physically bonds us is water. It's really like the courts are closing a roadway without it never having been used. Compensating for whales and taking positive steps to mitigate the spread of invasive species is not new to those who use our waterways. Commercial fisherman travel at high speeds and avoid the whales. Vessels from ports all over the world use our harbors. It seems the only way to really assess if the Superferry will cause additional stress is to allow it to operate on an interim basis. Even an environmental impact statement is only someone's best guess of potential harm.

As you know, surveys indicate that 80% of Hawaii residents want the ferry. Please do not force this value economic asset to leave our state!

My job involves screening and inspection of vehicles, our passengers and our passengers' personal items. It also involves boarding and loading the vessel. Dear Chairs Souki and Oshiro:

Thank you for the opportunity to testify on this important bill and thank you for holding this special session of the legislature to help me and other workers from Hawaii Superferry continue working.

Thank you for taking the time to listen to us and for your hard work and efforts going into this session. My name is **Chris Wong**. I am a furloughed port operator on Maui for the Hawaii Superferry. I am also the owner of a Christian clothing company. My strong support for the Hawaii Superferry goes far beyond my employment which I love dearly. The Superferry will also allow me to expand my business by bringing the materials and products I need to make presentations and attend shows. The Hawaii Superferry will also help me reduce my shipping costs, expand my business, create competitive prices statewide for goods and services I need, increase my network, allow me access to services not provided on Maui, and most important to me share my faith and increase mine.

As wonderful as <u>whales</u> are, people are more important. What major benefits do people really get from whales besides enjoying their beauty - shirts, postcards, toys, a tourist draw? Realistically, most residents don't have any more benefits from them than that. Most residents don't even get to see whales because they're too busy working. You have a choice between man and animal. You need to choose people first. One of our opponent's slogans is "Extinction is forever". That same slogan can be said for the local people who leave Hawaii because they can't survive economically. On the other hand, the Superferry could help enrollment increase for the UH system by allowing students easier access to our local college. It would make it easier for them continue their education here. The Hawaii Superferry will be the catalyst for residents to create new, exciting, and creative business, organizations, hobbies, and so on - and they may even get to see a whale or two.

I ask that you do not let our state become paralyzed and kept from greatness because you bought into "What if...." scenarios and their "fears of the unknown" being brought up by our opponents. Their concerns are the Superferry's as well, but we have not taken the extreme and pessimistic position they have. For instance, the traffic is basically a nonissue. Their issue is a lack of patience. It's no worse than politicians sign waving on the side of the road during the election season. The management of the Superferry has expressed to its employees that additional lots and routes as backup plans are available to us in the event of major traffic issues. One traffic concern of mine, however, is that the Maui terminal needs a limited protestor area like Kauai does for the safety of the protestors, customers, and employees. I'm not against their freedom of speech, but during the first full days of operations, the protestors caused unnecessary "rubbernecking" and unneeded pedestrian traffic around our entrance. Also, there was a protestor that tripped and fell near the outside of our entry gate - a place he shouldn't have been. As the on-duty officer we hired went to assist him, one of our employees was getting verbally harassed along the fence line while this took place. We also don't agree with protestors bringing their young kids to the side of a public road holding signs for a cause they don't fully understand. Also, it's difficult to take certain opponent groups seriously when one moment, they want to overthrow the existing Hawaiian government and it's laws. The next moment, they're crying "follow the law". Then they follow up by threatening to jump into the harbors and violate the stated restricted zones. I ask that this session create the designated protestor areas for Maui, and reiterates that any violation of the restricted areas will be treated as a domestic terroristic threat.

Certain people have reason to believe that the rock incident on Maui was an intentional and deliberate setup from our opponents. We don't want the Hawaii Superferry to be portrayed in a false, negative light because of stunts like this. For

example, how would you know if an opponent wouldn't intentionally spread an invasive specie to an island in an attempt to falsely accuse the Superferry during the assessment and/or EIS? And if the Hawaii Superferry must conduct these studies, you must require similar businesses such as the Pacific Whale Foundation to do the EA and/or EIS with the same conditions the Hawaii Superferry might be subject to.

Please consider the consequences that will occur if the Hawaii Superferry does not operate. Hawaii will have to repay the \$40 million. You will lose a valuable, state-of-the-art alternative mode of transportation, and the people of Hawaii will probably never have another opportunity to have a service like this from this company or any other similar companies. You are also at risk to be sued by the Hawaii Superferry. Young Brothers would continue its monopoly, and probably raise their prices knowing there won't be any direct or indirect competition in sight. Hawaii will lose many potential business prospects. Airline rates will go up. And these are just to name a few results of that decision. On top of that, you'd still have the whale collisions and the spread of invasive species.

For the majority of this ordeal, you have been asked to look at the negatives. However, I encourage you to consider the optimistic viewpoint. Consider the power of Hawaii's faith-based groups, the positive influence of clubs and organizations, the wise counsel and guidance of grandma and grandpa on the neighbor island, and so on. When I was a little girl, we used to fly back and forth to see my Aunts and Uncles on Oahu, who had to move off island because there were more opportunities there to support their families. I wanted to see the other islands but I was so afraid to fly. I asked my Mom, why doesn't someone build a bridge between the islands? My Mom told me "one day someone's going to build that bridge, you just have to be patient and it's going to be done." To me, Alakai is that bridge that I had dreamed about since I was a little girl. I am proud to be a part of the Hawaii Superferry and I believe it will be good for the residents and the businesses of Kauai.

Many of us on Kauai support the ferry and see the potential, but it is not our culture to speak out. We are intimidated by conflict. For those of us who grew up in plantation culture, we have been taught when there is conflict just let people say what they're going to say, just "let 'em go" and it will pass over.

Even now, when it's so important to speak up and let people know what we want, it is very hard for us to do it. Last night I met with 10 members of the staff and they were happy that I would go to represent them. Then I spoke with my family, and while they understood the importance of me going, they were also afraid for my grandson getting singled out in a school where the opposition is more popular. This week he received the school newsletter with information to audition for a play to dramatize the meeting with the Governor at the Convention Hall. It concerns me what we are teaching our children on Kauai about respect for other people by glorifying this day that was a shame for all of us as residents of the island. I respect everyone's point of view and everyone's entitled to their own opinion, but the violent way that opposition has been expressed makes it even harder for the "silent majority" to speak out. Thank you for letting me explain why I support Hawaii Superferry and believe this bill should be passed to allow Hawaii Superferry to operate while an EA is being conducted.

Hawaii Superferry provides a bridge between island families that is valuable to us, and gives more freedom to move around. Many residents do not like flying, and have trouble traveling with families. So many of us who are born and raised on neighbor islands have family on other islands, and this provides an affordable option to visit with them. With the recent price increase in shipping, it can actually be cheaper to travel with our own vehicle and definitely more convenient.

Some of us suffer from disabilities. I have been trained to assist people with disabilities and I myself have been diagnosed with a disability, and at one time I could not even climb the stairs. The idea of me not being able to lay down or spread out was a problem for me, and made travel to Oahu for medical treatment extremely difficult. There are many people with different conditions who would find travel by ferry more comfortable, and for some it may be the only way they can travel.

It's not easy to find a good part time job that works well with a full time job and still gives time with the family before going to bed. Many of our employees have to work a second job to supplement their incomes and make a living on Kauai. While I speak only for myself, many of my 35 colleagues on Kauai have also expressed similar opinions, and I hope you take that into consideration.

If the Hawaii Superferry isn't allowed to operate, it would be a loss not only for employees, but also for business on Kauai. Kauai has already been labeled as "anti business" and that creates a domino effect with the jobs and the whole economy. Please help us to preserve the Superferry, not only to help us keep our jobs for us, but also jobs for everybody.

Thank you for giving me a chance to testify on this important bill. My name is Kanoa Parker and I work as Chief Officer aboard the Hawaii Super Ferry, ALAKAI. Working on board the ALAKAI has given me the chance to work on state of the art equipment in the waters where I grew up, while at the same time advancing my license and career. To have this chance to work here in Hawaii as opposed to the Gulf of Alaska or the Far East, is really a wonderful opportunity.

Growing up on O'ahu, I have been around the ocean my whole life, whether it has been surfing, fishing, paddling or sailing. I have a great respect for the ocean, and Hawaii's environment. Working on the ALAKAI, I have come to find out that Hawaii Superferrie's environmental policies are more stringent and environmentally conscious than any company I have worked for. I have worked on tankers in Alaska, containerships and car-carriers sailing around the world, and just prior to the Superferry I was on the cruise ships sailing here inter-island.

Not only do our environmental and whale avoidance polices go well beyond the scope of other companies working here in Hawaii, but the maneuverability and handling characteristics of the ALAKAI make this vessel and company a wonderful asset to the state of Hawaii. With our no discharge policy, and stringent inspections for invasive species I feel confident about Hawaii Superferry making the least amount of impact on the environment as possible. All my fellow co-workers, whether on board, in the terminals, or in the office share my views. The amount of training and focus that the company has placed on the environment is very impressive.

The Hawaii Superferry is a great alternative to the state of Hawaii for inter island travel. From conversations with passengers on the few trips that we have done, and just this past weekend talking with some of the passengers who came aboard for our military appreciation cruises, there was an overwhelming consensus of how much everyone on board enjoyed themselves. They were so impressed with everything about the ALAKAI and our crew. This gave me a real sense of pride to be a part of this whole operation. I think the people of Hawaii deserve this alternative to travel. They deserve to have a choice of whether they want to use the Superferry to facilitate their businesses, or take their cars to outer islands to see their families. The Superferry has so many positive things that it can bring to Hawaii. Besides an alternative for travel, the vessel could be used as a major asset for disaster and emergency relief. This job is important to me because it's a learning experience, a chance to advance and to improve my skills and with good hours and good income for me and my family, so we can one day own our own home.

I like working for Hawaii Superferry because the management and the vessel crew is very friendly and it's something I would use myself.

Hawaii Superferry is another means of transportation that we want and need on Kauai. Since the rates of Young Brothers and Matson have been going up, it's important for us to have other choices of transportation besides airlines.

I was born and raised on Kauai, and know a lot of people here who don't like airplanes, and some who have never been off island. With Hawaii Superferry they could travel more for the first time and even take their vehicles to Oahu or Maui.

In my other jobs as a limosine driver and working in destination management, many of the people I work with and meet see many uses for the ferry here on Kauai. A manager of a construction company complained about a cement pump truck he was waiting for, that was stuck in Honolulu. It is still sitting in Honolulu, waiting for a barge and that has taken longer than the voyage from the mainland. If the Superferry was running, he could have driven the cement pump truck onto the Superferry. Others who are mechanics don't want to ship their vehicles with tools, but would take them on the ferry.

If the Hawaii Superferry isn't allowed to operate, it would be a loss not only for employees, but also for a lot of the businesses on Kauai that are planning to use the Superferry.

Please pass this bill, so we can get back to work.
