Members:

The Department of Business, Economic Development, and Tourism (DBEDT) supports Senate Bill 1, Senate Draft 1 (SB1, SD1) in which the Hawaii State Legislature adopts, clarifies and amends policies providing for continued operation of large capacity inter-island ferry service while any required environmental review and studies are conducted. We support the legislature's explicit finding that the operation of large capacity ferry vessels between Hawai'i's islands is in the public interest and that such a service "provides a real and innovative alternative to existing modes of transporting people, motor vehicles, and cargo between the islands of the state." We note that SB1, SD1 differs from HB1 that the House passed by inserting certain conditions related to whale-watching and invasive species. While SB1, SD1 replaces DBEDT with the Department of Agriculture on the temporary inter-island ferry oversight task force, we will provide any support needed by the Department of Transportation in carrying out the responsibilities of the task force and reporting to the Legislature and the Governor.

In spite of the testimony against the Superferry at the special hearings, it is clear that the majority of us in Hawaii are in favor of giving the Ferry a chance to operate successfully. The groups opposed to the Ferry that you have heard from are generally anti any progress and change. That is a sure path to disaster for us. We must innovate and change or be left behind as a second or third class community. A good point is made by Angela Chinen in the Oct. 24 morning Advertiser, Island Voices commentary. The State and the Super Ferry management went ahead after two judges had agreed that an EIS was not needed. Then the Supreme Court than took two years to decide to disagree. We simply can't function with these types of delays in government and judicial decision making. The Hawaii Environmental law, HRS C. 343 permits government agencies to specify exemptions to the requirement for an EIS. It is my understanding that the exemption previously granted for harbor improvements covered the kind of improvements made for the Superferry, and two judges apparently agreed. For rational individuals that should be enough assurance to proceed.

Another point. In spite of its size, the Ferry would most likely be seriously damaged if it hit a whale going at high speed. I am sure that this will further motivate the Ferry owners to operate carefully in the presence of whales, and I believe that is all we can ask.

Alaska, Washington and other locations all have very successful ferry service and now is the time for the great state of Hawaii to join them with state of the art ferry service. I would personally use the service in two ways: to visit neighbor islands a couple times a year plus just to cruise, occasionally (one day round trip). As far as the environment goes, it would seem that the ferry would be no more dangerous to the environment than the cruise ships or Young Brothers, even though the ferry goes faster and more frequently. Regarding the whales, the ferry should be safer since it does not have a propeller which could cut a whale if it got too close. When considering legislation for the Super Ferry, I strongly believe that restrictions should not be imposed on the Super Ferry that are not also imposed on the cruise ships and inter-island barges.

Also, I think it is terrible that a small minority (around 20% according to most polls) can dictate policy to the majority. Why aren't the cruise ships or inter-island barges required to get an environmental assessment? Could it be because they are not a threat to the air lines? It would not surprise me to learn that an air line (operating behind the scenes) stirred this up.

The majority of the people of Hawaii (around 80% from the polls I've seen) want interisland transportation choices. Hawaii Superferry is a transportation alternative that is wanted and needed by residents and businesses of Hawaii and will bring many benefits to our state.

To Whom It May Concern

My name is Raymond Lyman, I work for Catalina Express out of Los Angeles/Long Beach in Southern California. My position with the company is Vice President of Vessel Operations in charge of 11 vessels and a boat crew of 180 members. We run high speed passenger vessels across the San Pedro Channel to Catalina Island. I wish to comment on the extraordinary efforts the Hawaii Superferry has undertaken to operate safely in the environmentally sensitive waters of your beautiful Islands. I have read the operations scenarios developed by the Superferry company regarding Whale seasons routes and added crew observations and electronic detection. I have 25 years experience running vessels within the migratory route of the California Gray whales and have found that a trained eye can spot the air/mist blow of the whales miles away. Avoiding whales is much easier for the smaller high speed vessels than it is for the large container and deep draft ships transiting your island waters. I realize there are many objections to the Superferry operation, however, I feel it is of huge benefit to the majority of the Island residents and visitors to have such a service. Products grown or raised on one Island can be shipped fresh and at low cost compared to current available transport. Precautionary procedures can be followed to address non-indigenous species transport from one Island to another. And the fuel burn of the Superferry compared to the fuel burn of the small commuter jets per passenger has to be significantly less. In closing, I wish to comment on the Court activity as I see it. The same Court that gave early approval for the Superferry to proceed (with hundreds of millions of dollars being invested) is now allowing a vocal minority to bully it into closing down the operations. If businesses can't rely on the courts of our country to hold to their decisions regarding operations like Superferry, then who in their right mind would move forward with any particular service that could improve the lives and economic viability of the people served by the operation. If the Superferry is forced to shut down I believe it will not have the resources to come back into service and that will be a real shame. A shame on the court system and a signal to all businesses that investments are not safe when trying to provide new ideas and services.

My husband and I were in a market the other day and almost did not recognize a pile of Ahi in the fresh fish bin because it was so small. In the last thirty years we have noticed a marked decline in the size of Ahi, Aku and other seafood and fish sold in our local markets. There has been a 350% increase in recreational boats since 1960 according to the US Coast Guard. At the same time, there has been an increase in the whale population with 1000 calves born in Hawaiian waters this past year alone. With all those whales and all those small boats it was inevitable that some of the whales would be victims of collisions from boats, recreational boats. In 2006 to my knowledge, there were 7 (reported) collisions between small boats and whales. (You have to ask yourself, if every vessel that struck a whale actually got reported) One of these collisions, as we know, took place with a Whale Foundation vessel. Unfortunately, these things are sometimes unavoidable.

The decrease in size and variety of local fish, and increase in the number of recreational vessels might lead you to believe that these factors alone have quite an impact on our environment. You may even think an environmental impact statement is warranted. But of course other factors are involved here like the intentional and nonintentional introduction of foreign species that effect the local fish population, long line fishing, increase in the residential population, sonar fish finding devices, etc. Let me be clear that I support the endeavors of the Whale Foundation and would NEVER want to include their vessels in an EIS. The foundation serves an important educational need. I, and my family and friends have gone on whale watching tours and been amazed at those large marvelous creatures. My concern is that the Superferry is being singled out for envirnmental concerns when other factors are not being considered. Remember, those Really Big cruise ships dump their ballasts of foreign water in our Hawaiian waters and bring more than tourists to the islands, as do other large cargo vehicles. Also remember the increasing impact of foreign commercial fishing on our local fish population which could warrant an EIS all on its own.

I used to have a large and very productive vegetable garden with very few concerns about insects. Now my plants get attacked by bugs I have never seen before. I have been bitten by crab spiders, invaded by stink bugs and have my rose bushes invaded by Japanese beetles.

Lets not forget our poor wiliwili tree invasion by the gaul wasps and the mite attacking our plumeria trees. My daughter is a Horticultural major and could go on and on about species that have been intentially introduced, without proper environmental impact statement and have had a negative affect on our plants, birds, fish and reefs. Many pests have arrived here from foreign countries. How did they get here? Not rocket science to figure that one out. Just look how most of our belongings have arrived here.

My point is, that none of these environmental issues have anything to do with the Superferry. At all costs, the ferry will try to avoid collisions while altering their course during whale season. If you think about it, who has a better chance of hitting a whale; the huge number of recreational vessels making several whale watching or fishing expeditions a day or the once a day trip by the Superferry.

The Superferry is not going to bring anything to another island that couldn't be brought there by a tourist or cargo vessel. If I don't bring my car I would rent one, either way, one more car on the road.

Remember you need proof of ownership and insurance to take your car with you. The one concern that I really have, is residents coming from places like Oahu to Maui, Kauai, Hawaii with their fishing nets

and lay nets and fishing/diving equipment. The influx of visiting

fisherman who can take large coolers back and forth could have a negative effect on our local fishing areas. But, these kinds of concerns can easily be addressed by regulations and inspections of every vehicle prior to boarding, prohibition of certain fishing nets and equipment, and limits on the amount of seafood you can take home with you on the ferry not purchased commercially. If you want to stop the invasion of non native species, and other environmental concerns, banning the superferry won't have much impact at all, and I personally feel it will have little or no significant effect on whales.

Being a manager of a small Emergency Room and involved in the county's disaster response procedures, I feel that the ferry could be a life line connection between islands. there are also many of our citizens who cannot fly for one reason or another who could greatly benefit from an alternative mode of transporation.

In conclusion, I support the Superferry and hope to be able to take that trip i missed last month with my husband, next year. The Superferry will be a great service and enjoyment for our local population and a source for local employment. For those who want to ban the ferry, you had better include all the other large cargo and cruise ships, and the small recreational vessels in your EIS if your reasons are sincerely environmental. You may then ask yourself if the reported concerns about the Superferry are the real reasons behind the move to prevent its operation. You may be surprise at the answer.

Permits operation of large capacity ferry vessel company prior to completion of EIS upon meeting certain minimum conditions. Establishes a temporary Hawaii Interisland Ferry Oversight Task Force. (SD1)
