The Board of Directors of the Hawaii State Bar Association appreciates the opportunity to comment on the qualifications of James H. Ashford for the position of District Court Judge, First Circuit.

As the President of the HSBA, I am authorized to answer any questions or inquiries specific to HSBA policy and procedures for its rating of judicial nominees. At the outset IMMEDIATE PAST PRESIDENT please be advised that HSBA policy prohibits me from commenting or responding to questions with regard to specific reasons or the basis for the Board's rating of the nominee.

The HSBA Board has established criteria for determining the qualifications of judicial EXECUTIVE DIRECTOR nominees generally utilizing the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. The HSBA uses the following criteria in its deliberations: integrity and diligence, legal knowledge and ability, professional experience, judicial temperament, financial responsibility, public service, health, and ability to perform the responsibilities and duties required of the position for which the applicant has been nominated. Based upon these criteria, the HSBA Board rates judicial nominees either "qualified" or "not qualified."

As part of its procedures for evaluating and taking positions on judicial nominees, an email communication is transmitted to all active members of the HSBA to solicit comments and input on the individual nominated. The HSBA Board utilizes a subcommittee of the HSBA Board to review materials presented by the nominee, examine all comments and input from members, check references identified by the nominee, and contact others who have knowledge of the nominee's experience and qualifications.

The full HSBA Board reviews the materials prepared by the subcommittee, the materials and information submitted by the nominee, and the comments and input from members, and then conducts an interview of the nominee.

Taking into consideration all of the information presented by and about the nominee and an interview with the nominee, the Board of Directors of the Hawaii State Bar Association finds James H. Ashford to be qualified for the position of District Court Judge, First Circuit.

This letter is being submitted in support of the judicial nomination of James H. Ashford to the District Court of the First Circuit, State of Hawaii. For the reasons set forth below, I believe that Mr. Ashford is eminently qualified for the district court judgeship.

My personal knowledge of Mr. Ashford is based primarily upon a litigation case that took place several years ago in which Mr. Ashford and I represented opposing parties against each other.
