TESTIMONY OF MOMI CAZIMERO TO THE SENATE COMMITTEE ON TECHNOLOGY AND THE ARTS ON October 31, 2013 G.M. 34

Chair Glenn Wakai, Vice-Chair Clarence Nishihara and members of the Committee on Technology and the Arts, thank you for the opportunity to appear before you today.

I also want to express my warm aloha to everyone who submitted letters of support on my behalf.

It is an honor to be nominated by Governor Neil Abercombie to the Design Selection Committee for Art Work to Honor United States Senator Daniel K. Inouye.

In addition to following his many contributions to Hawaii throughout his life of extensive political service, I had the opportunity to get to know the Senator personally. I served on one of his many reelection campaign committees; was appointed by him to serve on a committee to review and recommend a meritselection process for Federal Judges; and participated in a gathering convened by Senator Inouye to coordinate efforts to advance the Recognition Bill for native Hawaiians. In my personal tribute to him I wrote: Hawai'i shaped who he became. In return—he shaped Hawai'i.

I want to serve on the Committee because Senator Inouye deserves the very best work of permanent commemoration in recognition of his notable legacy. I view that role as a personal obligation and want to assist in that process.

Act 281 enjoins United States Representative Patsy T. Mink and Senator Inouye in a purpose to create works in their honor that will inspire current and future generations. I am certain everyone will work to achieve that end; with each committee paying particular attention to their specific assignments. It goes without saying – we will incorporate the wishes of each of the families.

As a graphic designer I feel I can make an important contribution that is also unique. I own Graphic House, a design company I established in 1972. I served as a commissioner on the State Foundation on Culture and the Arts in 1997 and continue to serve on the SFCA Acquisition Committee. I have been a juror and co-juror of many art exhibitions throughout the state, and recently served as co-juror of the Honolulu Japanese Chamber of Commerce Commitment to Excellence Exhibition that attracts over 500 practicing artists in Hawai'i. Also, I am presently creating a commemorative plaque in honor of Ah Quon McElrath. Just as other committee members will bring their knowledge and expertise to the process—I plan to be guided by my experience in the arts, to create a respectful persona of Senator Inouye and Representative Mink.

In Hawai'i it is not appropriate to call attention to one's own qualities. I prefer using the descriptions expressed in my behalf: "... a community leader; ... a

talented designer; ... a role model". When my eulogy is delivered I hope my children will say — "My Mom is whom I would have picked."

I am proud of every award I've ever received, but truly, being selected a "Living Treasure" felt like being anointed. In an interesting way, the emotion I felt receiving that award, corresponds to this task. When the bar is raised, the expectations lift the outcome beyond the ordinary and obvious results. I am confident the artists will rise to the occasion. As a committee member I would want them to invoke strength, determination and foresight. Both Inouye and Mink overshadowed their modest beginnings, and yet they wore those humble attributes with a quiet pride. As abstract as that may seem, I know there are artists who can achieve results that will do us proud.

I do not anticipate a conflict of interest between my current business and personal involvement, and the service required on the Design Committee. But should a conflict arise, I will look to the committee for their input. I would follow procedures outlined in state regulations.
