I would like to thank Chair Josh Green, Vice Chair Rosalyn Baker, and members of the Health Committee for taking time out of their busy schedule to hear my testimony today. I would also like to thank Governor Neil Abercrombie for nominating me. It is truly an honor and a privilege to be considered to serve on the Disability and Communication Access Board (DCAB).

I have been living with a physical disability my entire life. However, I've never felt limited by my neuromuscular disease until recently when I became dependent on a cane to walk and a wheelchair to travel long distances. Almost instantly, my eyes were opened to a whole new world – one where

Without hesitation, he said, "as an Intake Advocate." Today, I am still working as an Intake Advocate. I enjoy helping others and providing guidance to those who need help.

Therefore, I want to continue my service to the disabled community by serving as a member of the DCAB Board. I feel that working as an intake advocate has given me insight to the disabled community and its problems from a different perspective, which allows me to see problems from the "inside-out" rather than from the outside looking in. Again, I would be honored to serve on the DCAB Board and hopefully be a great asset to its members.

In closing, I would like to thank again Governor Abercrombie, Chair Green, Vice Chair Baker, and members of the Health Committee for your time and consideration on my nomination. Mahalo.
