A BILL FOR AN ACT

PROPOSING AN AMENDMENT TO THE HAWAII CONSTITUTION TO DEFINE MARRIAGE AS THE LAWFUL UNION OF ONE MAN AND ONE WOMAN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to propose an
- 2 amendment to article I, section 23, of the Constitution of the
- 3 State of Hawaii to define marriage as the lawful union of one
- 4 man who is biologically male and one woman who is biologically
- 5 female.
- 6 The legislature finds that the unique social institution of
- 7 marriage involving the legally sanctioned union of one man and
- 8 one woman is a protected relationship of fundamental and
- 9 unequaled importance to the State, the nation, and society. For
- 10 millennia, this traditional marital relationship has proven to
- 11 be the foundation of strong and stable societies. The
- 12 legislature further finds that Hawaii's existing marriage laws
- 13 were intended to perpetuate this type of traditional family.
- In 1997, the legislature enacted H.B. No. 117, which
- 15 proposed amending the Hawaii Constitution to give the
- 16 legislature the power to reserve marriage to opposite-sex
- 17 couples. The proposed amendment, an assertion that social

- 1 policy issues of great importance should be decided by the
- 2 elected representatives of the people rather than by appointed
- 3 judges in the courts, was ratified by 69.2% of Hawaii voters
- 4 during the general election of November 3, 1998. Since that
- 5 time, however, the will of the voters who adopted this
- 6 constitutional provision in order to protect traditional
- 7 marriage has been disregarded by a vocal minority calling for
- 8 the legislature to radically alter the fabric of society by
- 9 permitting couples of the same sex to marry. Therefore, the
- 10 legislature further finds that it is necessary and proper to
- 11 submit this matter once again to the voters for resolution.
- 12 Although state law currently provides that a valid marriage
- 13 contract shall be only between a man and a woman, a
- 14 constitutional amendment that expressly defines marriage as the
- 15 lawful union of one man who is biologically male and one woman
- 16 who is biologically female is necessary to provide greater
- 17 clarity and specificity.
- 18 SECTION 2. Article I, section 23, of the Constitution of
- 19 the State of Hawaii is amended to read as follows:
- 20 "MARRIAGE
- 21 Section 23. [The legislature shall have the power to
- 22 reserve marriage to opposite-sex couples.] Marriage is the

- 1 lawful union of one man who is biologically male and one woman
- 2 who is biologically female."
- 3 SECTION 3. The question to be printed on the ballot shall
- 4 be as follows:
- 5 "Shall marriage be defined as the lawful union of one man
- 6 who is biologically male and one woman who is biologically
- 7 female?"
- 8 SECTION 4. Constitutional material to be repealed is
- 9 bracketed and stricken. New constitutional material is
- 10 underscored.
- 11 SECTION 5. This amendment shall take effect upon
- 12 compliance with article XVII, section 3, of the Constitution of
- 13 the State of Hawaii.
