
HOUSE RESOLUTION

RELATING TO MINORITY LEADERSHIP AND COMMITTEE ASSIGNMENTS OF THE
HOUSE OF REPRESENTATIVES OF THE TWENTY-SEVENTH LEGISLATURE.

1 WHEREAS, the leadership coalition between the Majority and
2 Minority Caucuses of the House of Representatives has failed to
3 operate with transparency or to institute a forthright
4 deliberate process, and this failure has short-changed the
5 interests of the public and their representation in legislative
6 matters; now, therefore,

8 BE IT RESOLVED by the House of Representatives of the
9 Twenty-seventh Legislature of the State of Hawaii, Second
10 Special Session of 2013, that the leadership coalition between
11 the Majority and Minority Caucuses is hereby dissolved through
12 the withdrawal of participation by the Minority Caucus
13 membership; and

15 BE IT FURTHER RESOLVED that GENE WARD shall replace AARON
16 LING JOHANSON as the Minority Leader of the House of
17 Representatives; and

19 BE IT FURTHER RESOLVED that AARON LING JOHANSON shall no
20 longer be a Vice Chair of the Finance Committee, but shall
21 remain as a member of the Finance Committee; and

23 BE IT FURTHER RESOLVED that GENE WARD shall no longer be
24 the Vice Chair of the Economic Development & Business Committee,
25 but shall remain as a member of the Economic Development &
26 Business Committee; and

28 BE IT FURTHER RESOLVED that the Speaker of the House of
29 Representatives shall appoint a member of the Majority Caucus to
30 serve as the Vice Chair of the Economic Development & Business
31 Committee; and

18 Resolution, all appointments and committee memberships of the
19 House of Representatives adopted by the House of Representatives
20 of the Twenty-seventh Legislature of the State of Hawaii,
21 Regular Session of 2013, shall remain in full force and effect;

25 assignments made by this Resolution shall take effect upon the
26 Resolution's adoption.
