My name is Shylar Young and I am 13 years old. My parents are Tambry and Suzanne Young. My moms have been together for 32 years. But because they weren't granted the same benefits that are given to straight married couples, our family had to pay an extra \$1500 to the government this year. That may not seem like a lot to you, but to me that's a lot of money. And if you multiply that by the 4 years that I've been here with my moms fighting for our rights, that's \$6000!

So how does my family paying more to the government, and my moms living happily as a married couple hurt the people who don't support us? I don't think it hurts them at all but it really hurts me and my moms. So what if their kids will have to learn and accept it in school – families like mine are already in our schools and you know what, we all get along.

My moms love each other regardless. Nothing will stop them from loving one another. How does our family's happiness and love affect those who are against us? This shouldn't even be an argument! Marriage is between two people that love each other. It's not something that should be put to a vote. By allowing my moms to be considered married in Hawaii it will only give them what every other straight married couple has. All we ask is to have all the rights, protections and responsibilities that every other straight, married couple has.

When we were up in Massachusetts recently, no one cared. It didn't affect their lives like how some people are saying it would. We met many people that have congratulated my moms for their marriage. They don't care anymore, it's just part of life for them. In fact, a lot of the people we met thought we had marriage already in Hawaii.

Many of the people against marriage equality believe that I will be weird, but how would they know. They don't know me. What they are doing is a type of bullying. Why are grown men and women bullying a 13 year old girl? They do not know me; they just assume that I will be weird. So tell me how weird is it that I am a member of the National Honor Society, have a 4.0 GPA,

and my first film was in the Hawaii International Film Festival and is being considered for the New York Film Festival. Gee how weird is that?

Singers Macklemore and Ryan Lewis said "we live in a world so hateful some would rather die than be who they are." What this means is because of those who bully gay people and make them feel it's bad to be gay when it's not, they feel so much hurt they kill themselves. And do you know what the Bible says, "thou shall not kill". Therefore if we are considered evil for just loving one another, I wonder how evil they are for making people feel like they need to kill themselves.

I really don't understand what's the big deal! And neither do many of my friends. So what if a man and a man love each other, it's none of any of our business. Right now what it seems to be is that the people going against us are just trying to cause drama. That's it. There's no reason how having two people of the same sex love each other should be such a big deal. It's rude, it's crazy, and it's just not necessary for those who oppose same-sex marriage to fear it. It's none of their business how our family lives. But it is the government's business to ensure our family is treated the same as all other families and that we are provided equal rights under the law as required by the US Constitution.

And so I ask you to support families like mine and vote to pass this marriage equality bill. Thank you.

I am writing to voice my opposition to Bill SB1.

Let me tell you why.

My mom chose to be in a relationship with another woman. It has had a lasting effect on my siblings and I for over three decades.

This is how it's affected me during my elementary school days. The reality of my mom's relationship would bring random thoughts of depression that also included the weight of darkness and gloom. I knew in my heart of hearts that my family secret would have its way with me from both angles, my mom was no longer in my life and my peers would eventually find out and rub it in my face. The questions from peers began to come "who's that lady your mom is always with? Where's your dad? How come your mom doesn't live with you?" These questions haunted me as a little girl. Now looking back I realized that no other adult had the courage to confront her or even speak up to tell her that her instant gratification was bringing heart ache and sadness in her kids. My mom has since ended her relationship with her partner but not without a price to pay. Allowing herself to feel the joy that she is entitled to when spending time with her children and grandchildren does not come so easy. Almost as if she must earn her position as mom and grandma. There aren't enough "I love you" and "I forgive you" that can encourage her being present body and mind with all of us. Even though my mom tries to move forward it's as if she is tormented by the choice she has made for almost half of her life to spend it with another woman.

It is clear from my experience that passing this bill will have disastrous consequences not only for the immediate family involved but also in the long run to the couples choosing to live a lifestyle of homosexuality.

I realize that I have no control over the MANY people choosing a lifestyle of homosexuality but as a mom I CHOOSE to practice self-control when it comes to sexual relation for the good of my children and the little eyes looking up to me as a coach, an aunty, and an educator. Below is the complete text of the Gay Manifesto first Published in Gay Community News, February 15-21, 1987

"We shall sodomize your sons, emblems of your feeble masculinity, of your shallow dreams and vulgar lies. We shall seduce them in your schools, in your dormitories, in your gymnasiums, in your locker rooms, in your sports arenas, in your seminaries, in your youth groups, in your movie theater bathrooms, in your army bunkhouses, in your truck stops, in your all male clubs, in your houses of Congress, wherever men are with men together. Your sons shall become our minions and do our bidding. They will be recast in our image. They will come to crave and adore us.

My name is Winona Fuller and I strongly oppose Bill SB1. My concerns on this bill is about Religious Exemptions. There are 3 conditions that must be met by religious organizations in order to exempt them from legal harassment, should they refuse to make their facilities available to same-sex weddings.

- 1. The religious facility is regularly used by religious organizations for its religious purposes.
- 2. The religious organization restricts use of the religious facility exclusively to its members.
- 3. The religious organization does not operate the religious facility as a for-profit business.

If any of these 3 conditions are not met, then the protection of the section does not cover that religious facility. Condition 2 is the most sickening part because almost all houses of worship that I know of do not restrict their facility (chapel, gyms etc.) exclusively to its members. Most churches welcome visitors not of their faith and therefore this condition voids the entire so called "religious exemptions". This where we draw the line.

Another huge flaw in the religious exemption is that it does not cover religious affiliates of churches such as Catholics Charities and other church owned adoption agencies. Schools owned by a church are not protected such as the Mormon owned BYUH in Laie or the adjacent PCC. These affiliates and their employees should also be covered under the religious exemptions because constitutionally, they also have the right to free exercise of religion and should not be forced to go against their religious beliefs. One of the biggest complaints about this bill is that it is selective in who it grants religious liberty to.

For years and years, church and state has always be separated and is still separated, so why is the state getting involve with religious rights.

Honorable Members of the Judiciary and Finance Committees:

I raise my voice in opposition to SB 1 for the reasons sated below:

First, what is the crisis that this special session was called to address? Why are we rushing through a bill, the ramifications of which we don't fully comprehend yet? How can the issue of redefining the sacred and long-standing institution of traditional marriage, even the foundation of our society, be decided in a matter of days? This process is unfair and wrong.

Second, I urge you to hold SB 1. The magnitude of redefining marriage will impact the very fabric of our society. Such a radical and drastic change should be entrusted to the people, as many other states have done. A constitutional amendment is the purest way for a society to govern itself.

Third, the religious exemptions in the bill are woefully inadequate. If the bill is going to move forward, it must include broader exemption language to protect the religious liberties and freedoms of religious conscience that are enshrined in the state and federal constitutions. As drafted, SB 1 includes exemptions that are not true exemptions at all. The bill states that clergy cannot be forced to marry same-sex couples and that religious property and facilities don't have to be used for same-sex ceremonies. I don't think anyone expect clergy and the use of their facilities to be forced to perform religious ceremonies that are in direct contradiction to their doctrines and beliefs. And most, if not all, churches are non profit by their very nature.

Churches that own, operate, manage or control other non-profit divisions and affiliates, such as schools, charity groups, social service providers, welfare distribution centers, etc. also need protection under such religious exemptions.

Conscientious objectors who own sole proprietorships or other small businesses cannot lose their rights of religious conscience and freedom simply because they are organized for profit. "For profit" means sustaining a livelihood. Right now, SB 1 affords no protection to a small business owner who refuses to provide services to same-sex couples on grounds that to do so would violate her deeply held religious beliefs.

The rights of parents, students and teachers in a public education setting is not addressed in this bill. What happens if parents refuse to allow their children to be taught moral ideologies that contradict their deeply held religious convictions? Do students have a right to opt out of such

teachings? What about teachers who refuse to teach material that violates their core religious values?

If these and other gaps are not filled with specific, acceptable exemption language, this bill, if it becomes law, will spur litigation for years to come. Please, if this bill is to move forward, consult the exemption language in House Bill 6 and the exemption language of other states' marriage laws that have addressed these issues, such as, Connecticut, the District of Columbia, Maryland, Minnesota, New Hampshire, New York, Rhode Island, Vermont, and Washington. Broadening the exemptions accordingly would go a long way in balancing constitutionally protected religious liberties with the marriage privileges same-sex advocates seek here.

I am opposed to this bill because:

It needs to be properly vetted in the appropriate committees: Education, Health and Human Services. Because this bill has such devastating, far-reaching effects it should not be confined to only two committees in five days. That is akin to forcing you make an important personal decision in your life in 5 minutes.

This tells me that, perhaps, regulation and money are considered to be more valuable to you than the Education, Mental and Physical Health of our keiki, Hawaii's children. I am writing in strong support of SB 1.

I am a board-certified pediatric intensivist, in other words, a doctor who takes care of Hawai'i's sickest children from after the newborn period to age 21 years. If a child's heart or lungs stop working, I help put them on a heart-lung bypass machine, a procedure which may allow the non-functioning organs time to heal. To do what I do I graduated from college magna cum laude, graduated from a top ten Ivy League medical school with both honors in research and in the national medical honor society, and spent three years each in two of the nation's finest training hospitals. I've spent the last nine years striving to do my best caring for the children of Hawai'i. Because of my scholarship in medical school I was awarded an international fellowship and spent a year in Rio de Janeiro studying tuberculosis, and there met Alex Ribeiro, the man of my dreams, 17 years ago this December 7th.

My parents were supportive and they provided the initial sponsorship for Alex to study in the United States. In 2004, I followed Alex to Hawai'i where he had come the year before to join the nation's only doctoral program of architecture. Following his graduation, Alex worked for the Bishop Museum, responsible for making the drawings that would turn its Polynesian Hall into the Pacific Hall. On July 10th, 2012, though we had been together almost 15 years, we had no mechanism to keep Alex in the country legally, and so he moved back to Brazil. This summer, following the United Stated Supreme Court decision that Section 3 of the Defense of Marriage Act was unconstitutional, we applied for our fiancé visa which has the requirement of us marrying within 90 days of arrival in the United States.

I relay this personal and detailed background to fulfill my civic duty and provide a first hand account of our experiences because the legislation you are debating directly impacts our lives.

We wish to marry here in Hawai'i, as it is our home. Our friends, family and colleagues want to celebrate with us. Either cost or duration preclude long journeys for many of my family. Marrying in California deprives us of that support during one of life's most significant events.

I like to state my support for the extension of "equal rights and benefits" to all individuals and their relationships in keeping with constitutional due process of law and equal protection of the laws; however, not by and through an arbitrary, confusing and unfair legislative act of changing the nature of "marriage".

Gay marriage is an equal rights issue rather than a marriage issue. That being the case, there is no need to change the nature of marriage by means of an arbitrary, confusing and unfair definition. What is needed is amendment of laws extending certain "rights and benefits" to married couple (manand-woman unions) in order that the same "rights and benefits" would be available to "certificated" same-sex couple, whatever such relationships might be called (e.g. civil unions; domestic partnership; "groomage" for a man-and-man union; or "brideage" for a woman-and-woman union). What is needed is "certification" to the legitimacy of such same-sex union or relationship.

Changing the nature of marriage by an arbitrary, confusing and unfair definition as proposed by the legislation is extending "special treatment" to same-sex couples. Marriage is the legal union between a man and a woman. Water (science tells us) is H_2O , not H_2H or O_2O . The use of the word "gay" or "same-sex" before "marriage" to identify such proposed would-be unions underscores that such relationships are, in some significant ways, other than "marriage".

"Special treatment" is anothema to "equality", especially when such "special treatment" proceeds from an arbitrary definition or interpretation of factors and circumstances.


