Good afternoon Chair Tokuda, Vice Chair English and members of the Senate Committee on Labor. I am Allicyn Tasaka, Executive Director of the Workforce Development Council (WDC) testifying in support of Dwight Takamine's confirmation to the WDC for a term to expire on June 30, 2020. Mr. Takamine would fill a slot reserved for a labor sector member on the Council.

The WDC is an attached agency to the Department of Labor and Industrial Relations and is responsible for advising the Governor and Legislature on workforce development to support economic development and employment opportunities for employers and employees. The WDC is the State Workforce Development Board for purposes of the federal Workforce Innovation and Opportunity Act (WIOA) of 2014 and is the designated agency to administer and implement WIOA for Hawaii. The WDC assists the Governor in developing and updating comprehensive, strategic workforce development plans and oversees publicly funded workforce investment activities in the state.

Dwight Takamine is currently the Legislative Director of the ILWU Local 142. He has also been Director of Student Success and Community Relations for the University of Hawaii, West Oahu; Director of the State Department of Labor and Industrial Relations (DLIR); and a member of both the Hawaii State House of Representatives and the Hawaii State Senate.

WDC is in the process of transitioning the State workforce system to the new requirements under WIOA. WDC received approval of Hawaii State Unified Plan which covers the six core formula grant programs authorized under WIOA and outlines the state's vision and strategy for carrying out activities under each program. The WIOA plan is a requirement in order for Hawaii to receive the bulk of federal funding for the State's primary job training and placement activities and WDC must now implement the state-wide plan.

Mr. Takamine's experience in the different facets of workforce development while working as a legislator, as the Director of DLIR, with organized labor, and with the University of Hawaii make him a valuable resource to the WDC.

I respectfully urge you to confirm Dwight Takamine as a member of the Workforce Development Council where he would be a valued asset to the Council.

Thank you for the opportunity to provide testimony on this matter.

The ILWU strongly supports the confirmation of **Dwight Y. Takamine** for the Hawaii Workforce Development Council.

Dwight is currently the Legislative Director for the ILWU and possesses a wealth of knowledge and understanding of workforce issues due to his varied experiences. An attorney by education and training, Dwight served more than 25 years in the State House of Representatives and the State Senate and was chair of the Labor Committees in both houses. In 2011, Dwight was appointed Director of the Department of Labor and Industrial Relations and served four years, becoming intimately acquainted with each of the Divisions, including the Workforce Development Division and the Workforce Development Council. Subsequently, Dwight worked on workforce issues for the University of Hawaii West Oahu before joining the ILWU.

Dwight works for a labor union and advocates for workers, but he knows that good employers are needed to sustain good jobs. Dwight is well aware that balance is required to make workforce development benefit Hawaii as a whole.
