It is my intent to represent Maui on the DCAB board and to bring my understanding of current DCAB concerns back to Maui architects and engineers. I also will serve on the Facility Access Committee and help to respond to individual requests for exemptions to the DCAB standards and to formulate official changes to policies where warranted.

- (6) Name three qualities that best describe you and how these qualities will benefit the Board.
 - When the American's with Disabilities Act was first issued in 1991 I made it a point to learn everything I could about the new rule. Since that time I have performed over 100 site audits throughout Hawaii for compliance with ADA, the Fair Housing Act and other safe harbors.
 - As an Architect I have been trained as a problem solver and will bring that ability to the DCAB board meetings and my duties as a member.
 - It is in my nature to be prompt and to always attend scheduled meetings on time having reviewed prepared materials submitted prior to the meeting.
- (7) Name a previous experience you've had that will be beneficial as a Board member.

I served two terms on the DCAB Board from 2000-2009. As an Architect I was on the Facilities Access Committee for the majority of that time. During the intervening eight years I have continued to attend DCAB workshops on Maui and on Oahu and to provide Accessibility Audits for government and commercial properties.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest? Our architectural firm (Kimmey Unabia Architects, Ltd.) rarely takes on State or County projects. If we do find ourselves involved in a project under review by DCAB I will recuse myself from any discussions regarding that project.
