

### Distinguished Committee Members:

I am an astronomer (PhD in astronomy from the University of Texas in Austin) employed at UH Manoa as a "casual hire" for the past two years, payed on a per-credit rather than a salaried basis. I must teach a minimum of seven (7) credit hours each semester to qualify for benefits, including medical and participation in the pension fund. At present, I teach a total of ten (10) credit hours.

This semester, typical of most, I instruct over 400 UG students, who take one of my two semester (one academic year) physics sequence, in order to satisfy the requirements for their pre-medical, pre-dental, engineering and other "hard" sciences degrees. The majority of full-time faculty in my department teach at most one UG class and/or one graduate-level class or seminar, instructing less than 30 students. Yet I earn approximately only two thirds of the department's minimum yearly salary.
