SENATE RESOLUTION

AMENDING RULE 16 OF THE RULES OF THE SENATE OF THE TWENTY-NINTH LEGISLATURE OF THE STATE OF HAWAII.

BE IT RESOLVED by the Senate of the Twenty-ninth Legislature of the State of Hawaii, First Special Session of 2017, that the Rules of the Senate of the State of Hawaii, the Twenty-ninth Legislature, be amended by deleting paragraphs (10) and (11) of Senate Rule 16 Standing Committees to read as follows:

"[(10) Committee on International Affairs and the Arts (IAA). The purview of this committee includes those programs relating to international affairs, international relations, foreign policy issues, and foreign relations; and culture and the arts in the State, including but not limited to programs relating to historic preservation.

(11) Committee on Judiciary and Labor (JDL). The purview of this committee includes those programs relating to the courts, crime prevention and control, including juvenile justice matters, criminal code revision, statutory revision, campaign spending and elections, ethics, constitutional matters, the Attorney General, Public Defender, and Judiciary, and individual rights and civil liberties; and public officers and employees, labor, employment opportunities and training, labor management relations, collective bargaining, the Employees' Retirement System, and the Hawai'i Employer Union Health Benefits Trust Fund.]"; and

BE IT FURTHER RESOLVED that the Rules of the Senate of the State of Hawaii, the Twenty-ninth Legislature, be amended by adding two new paragraphs to Senate Rule 16 Standing Committees to read as follows:

"(10) Committee on Judiciary (JDC). The purview of this committee includes those programs relating to the courts, crime prevention and control, including juvenile justice matters,

criminal code revision, statutory revision, campaign spending and elections, ethics, constitutional matters, the Attorney General, Public Defender, and Judiciary, and individual rights and civil liberties; international affairs, international relations, foreign policy issues, and foreign relations; and culture and the arts in the State, including but not limited to programs relating to historic preservation.

(11) Committee on Labor (LBR). The purview of this committee includes those programs relating to public officers and employees, labor, employment opportunities and training, labor-management relations, collective bargaining, the Employees' Retirement System, and the Hawai'i Employer-Union Health Benefits Trust Fund."; and

BE IT FURTHER RESOLVED that the Senate Rule material to be repealed is bracketed and stricken and new Senate Rule material is underscored; and

BE IT FURTHER RESOLVED that the amendments made to the Senate Rules by this Resolution take effect upon the adoption of this Resolution.
