Dear Senator Karl Rhoads:

I write on behalf of Mr. Ronald G. Johnson's nomination to the Circuit Court of the First Circuit.

I first met Mr. Johnson while he was a prosecutor in District Court of the First Circuit in the early 1990s, which is where all young prosecutors begin. It is also one of the most challenging places to start because of the fast pace, variety, and unpredictability of the cases. Yet in the time that Mr. Johnson practiced before me, he was always thoroughly prepared, extremely level-headed and fair.

Mr. Johnson was a quick study and very quickly became a supervisor, helping other young deputies to learn the ropes. Despite having a full caseload and managerial responsibilities, Mr. Johnson volunteered to assist the judiciary with the implementation of the decriminalization of traffic offenses in 1993. The judiciary had less than one year to: 1) create a civil traffic system for the less serious traffic violations, 2) train all judiciary personnel statewide, 3) create forms and traffic infraction schedules to replace the bail schedules, and 4) train all law enforcement agencies statewide.

Mr. Johnson assisted with the creation of the traffic infraction fee schedules. It was during this intense period of time, that I became even more familiar with Mr. Johnson. We met frequently and I observed his work ethic, legal knowledge, and his dedication to public service.

Creating the new infraction fine schedule was no small task. In fact, it was a mammoth one. First of all, each county had their own collection of bail schedules for both state and county offenses. The decriminalization of traffic offenses statute required statewide uniformity. The fines for the same statewide traffic offense varied greatly from county to county, with Oahu on the high end and Kauai on the low end. And then there was a matter of identifying the similar offenses in the respective county codes and matching them to the state statutes, a tedious and labor-intensive task. While I worked with the judges on reaching agreement, Mr. Johnson worked with his counterparts on the other islands. Securing agreement required patience, persuasion, and persistence.

I have followed Mr. Johnson's career as an assistant U.S. attorney and now as an attorney advisor to the Transportation Security Administration. He has continued to handle himself with the same professionalism and dedication of a true public servant.

In my experience, Mr. Johnson has demonstrated diligence, legal knowledge and ability, integrity, and a commitment and dedication to public service. He will be an outstanding circuit court judge.

- Meeting of the President, the Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Mr. Johnson on September 6, 2019 to discuss the subcommittee's findings. On September 9th, Mr. Johnson was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Mr. Johnson was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Mr. Johnson in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

Beginning in 1990 at the Department of the Prosecuting Attorney for the City and County of Honolulu, and subsequent employment in the United States Attorney's Office, Ronald G. Johnson has gained a wealth of experience in the practice of criminal law. As a senior supervising attorney in the U.S. Attorney's Office, Mr. Johnson was responsible for the review of cases to determine if prosecution was warranted. This process involved a review of the facts presented and applicable law, discourse with investigative staff, and if prosecution was deemed appropriate, the appropriate charging of alleged crimes.

As an attorney assigned to handle complex white collar crime cases involving fraud and financial irregularities, the Nominee was required to become knowledgeable prosecuting cases involving complex facts and criminal law, as may be similarly present in complex civil cases and was required to prove such cases to a higher standard than civil cases; proof beyond a reasonable doubt. Mr. Johnson's tenure as a TSA Attorney Advisor for Pacific Rim Airports has provided the Nominee with the opportunity to transition to civil practice providing advice on collective bargaining, and human resources and civil penalty assessment issues.

Through his professional career and courtroom experience, the Nominee appreciates the need for judges to exhibit appropriate demeanor and to possess people skills, knowledge and compassion when dispensing justice.

Pursuant to your press release of February 5, 2018, which seeks "public comment," Assistant United States Attorney Ronald G. Johnson is one of the attorneys whom you are considering for appointment as a Judge of the Circuit Court of the First Circuit. This letter constitutes my strong recommendation in support of appointing Ron to that judicial position.

I have been an active member of the Hawaii bar since 1968. My law firm is based in Honolulu and specializes in criminal defense practice and constitutional law. Additionally, I serve as a Lecturer in Law, co-teaching the Hawaii Innocence Project seminars at the University of Hawaii's William S. Richardson School of Law. I have extensive personal experience practicing in the Circuit Court of the First Circuit (among other courts), the particular court to which Ron seeks appointment as a judge.

I have known Ron for many years, and I have worked closely with him (although on opposing sides) during his lengthy employment as a federal prosecutor. For example, I was one of the defense attorneys in the heavily publicized case involving Mexico's attempted extradition of bounty hunters Duane "Dog" Chapman, Leland Chapman and Tim Chapman, while Ron represented the United States government in that case.

I have always found Ron to be fair, willing to consider different viewpoints, a man of integrity, and an intelligent attorney who possesses extensive legal knowledge. In my experience, Ron also has the appropriate temperament and social skills to be a successful First Circuit Court judge.

Ron has been an Assistant United States Attorney in the District of Hawaii since 1995, and has had a varied and well-balanced range of experience within that large office. He currently serves as Senior Litigation Counsel, with responsibilities that include training attorneys and legal support staff. He also serves within the Fraud and Financial Crimes Section, investigating and developing complex white-collar crime cases including those involving Ponzi schemes, tax evasion, cyber crime, identity theft, procurement fraud, health care fraud, wire fraud, mail fraud and bank fraud. Among his former positions, Ron was previously the Chief of the Major Crimes Section, where he supervised up to eighteen attorneys and six members of the support staff, investigating and prosecuting major crimes such as national security matters, firearms offenses and child exploitation. Additionally, Ron formerly served as the Chief of the Violent Crime Section, supervising up to eleven attorneys in the prosecution of offenses of violence, theft, robbery, and crimes committed on military installations and other federal property. Ron has received awards, letters of recognition and certificates of appreciation from various agencies and officials during his career as a federal prosecutor, including induction into the Hawaii Joint Police Association's Hall of Fame.

Prior to becoming a federal prosecutor, Ron worked as a City & County of Honolulu prosecutor from 1987 to 1995, including his service as the Director of the Misdemeanor Division and as the Chief of the DUI/Traffic Branch. Significantly, Ron has valuable "hands on" experience personally prosecuting felony cases in the First Circuit Court, including case investigation, motions practice, trial preparation, trial presentation, and sentencing.

Ron's education includes a Juris Doctor degree from the William S. Richardson School of Law and a Bachelor's degree in Business Administration from UH's College of Business Administration. Ron has been happily married since 1983 and has raised two successful adult sons. Notably, Ron stays in shape with running, swimming, marathons, triathlons and biathlons, so he would definitely possess the necessary energy and stamina to handle the demands of being a trial judge in the First Circuit Court.

Finally, although much of Ron's legal experience has been as a federal prosecutor, that would not hinder him in properly understanding and applying the State of Hawaii's case law, statutory law and rules (as he did while serving for more than eight years as a City & County of Honolulu prosecutor). Various former federal prosecutors from the District of Hawaii currently serve (or previously served) with distinction as judges for State of Hawaii courts. They include our current Chief Justice Mark E. Recktenwald of the Hawaii Supreme Court, who was an Assistant United States Attorney in the District of Hawaii from 1991 to 1997 and then from 1999 to 2003; soon-to-retire Chief Judge Craig H. Nakamura of the Hawaii Intermediate Court of Appeals, who served as an Assistant United States Attorney in the District of Hawaii from 1986 to 2004; current First Circuit Court Judge Edward H. Kubo, Jr., who served as the United States Attorney for the District of Hawaii from 2001 to

2009, and prior to that was an Assistant United States Attorney in the District of Hawaii for eleven years; and First Circuit Court Judge Steven S. Alm (now retired from the bench) -- the winner of the Hawaii Judiciary's "Jurist of the Year" award in 2010 and the Hawaii State Bar Association's "Golden Gavel" award in 2015 -- who served as the United States Attorney for the District of Hawaii from 1994 to 2001. Additionally, former State of Hawaii Attorney General Mark Bennett (who was recently nominated for appointment to the Ninth Circuit Court of Appeals) worked as an Assistant United States Attorney in the District of Hawaii from 1982 to 1990.

In light of all of the foregoing, I firmly endorse Ron Johnson's application for appointment to the bench of the Circuit Court of the First Circuit. I am confident that he will serve with distinction if he is selected for that position.

I am writing to strongly recommend Ronald G. Johnson for appointment to the Circuit Court of the First Circuit. I have known Ron for over 13 years. On a daily basis, I have observed his diligence, legal knowledge and ability, professional experience, temperament, public service, and health, all that will make him an outstanding judge.

As a prosecutor for over 30 years, Ron has tremendous experience in the courtroom. Ron was my supervisor for three years when I began at the United States Attorney's office in 2006. He was a patient and nurturing supervisor. Since then, he has been a mentor, colleague, and friend. I have seen Ron's strength as a leader and a consummate team player. This backed up traffic and caused a hazard as cars tried to get around the moped. As Ron stopped to help the young man, a large truck pulled up behind us to help. Ron and B.J. lifted the moped into the back of B.J.'s truck and B.J. took the young man and his moped to the young man's house. This showed me two things about Ron: 1) he acts when it is the right thing to do – not for personal gain, and 2) he has instilled this in his sons. Ron's selfless nature is extraordinary.

Having known, learned from, and grown because of Ron, it is my privilege and pleasure to recommend him for appointment to the Circuit Court of the First Circuit. Ron's time as a Deputy Prosecuting Attorney and a supervisor with the Honolulu Prosecutor's Office will make his transition back to State Court seamless. Ron will be an excellent jurist, and would serve the judiciary well. Most of all, he is a good person with a big heart. I have no doubt he possess all that is necessary to fulfill the responsibilities and duties required to be a Circuit Court judge.

I am a Professor Law at the William S. Richardson School of Law, University of Hawai`i. I am writing to strongly urge your committee's favorable action on the nomination of Ronald G. Johnson to the First Circuit Court, State of Hawai`i

Mr. Johnson was a law student when I started teaching at the Richardson Law School. During that period we interacted closely, and I have kept in contact with him these many years and followed his career as an Assistant United States Attorney. Mr. Johnson is a person of outstanding judgment, fairness and maturity And he has exceptional courtroom experience as a federal prosecutor. He will, in my estimation, be a superb trial judge.

I respectfully submit the following testimony in support of Ronald G. Johnson's nomination to as Circuit Judge, Circuit Court of the First Circuit.

I have had the honor and privilege of Mr. Johnson's acquaintance for the past 13 years. We first met in 2006 when I started working at the United States Attorney's Office for the District of Hawaii as a criminal paralegal in the Drug and Organized Crime Section. At the time, Mr. Johnson was the Chief of the Major Crimes Section. His office was just a few doors away from mine and although he was a very busy supervisor, he was never too busy to stop and say "hello" or ask how my family and I were doing. In September 2015, I left the U.S. Attorney's Office. While I unfortunately do not get to see Mr. Johnson as regularly as I did while working at the U.S. Attorney's Office, we continue to work together and remain close personal friends. Having worked with Mr. Johnson in several different professional capacities and after getting to know him personally, I am firmly certain that Mr. Johnson would be an outstanding judge.

Mr. Johnson has years of experience litigating in both federal and state courts in the State of Hawaii.
