- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.

The HSBA President and the Executive Director met with Judge Morikawa on September 6, 2019 to discuss the subcommittee's findings. On September 9th, Judge Morikawa was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Judge Morikawa was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Judge Morikawa in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The Honorable Trish K. Morikawa has served as a per diem District Family Court Judge of the First Circuit from February 2015 to April 2017. In May of 2017, she was appointed as District Court Judge. Since January 2019, the Nominee has been temporarily assigned to the First Circuit Court. During her tenure as a judge, Ms. Morikawa has presided over an extensive number of jury and bench trials.

Prior to her service on the bench, Judge Morikawa was in the private practice of law for 5 years providing legal services to businesses and individuals in commercial, automobile and homeowner insurance litigation in State and Federal Courts. The Nominee also has experience in arbitration and mediation. She has also served as the Housing Coordinator for the City and County of Honolulu, a Deputy Prosecutor, and a Deputy Attorney General.

Her experience on the bench has provided the Nominee with an appreciation of the jurisdictional responsibilities of the District and Circuit Courts. In addition, Judge Morikawa's community service activities, including her 8-year tenure as a Commissioner on the Hawaiian Homes Commission, is a further reflection of her commitment to serve the people of the State of Hawaii.
