

In all matters, she has been a principled advocate and the consummate professional, regardless of the final outcome of the appeal. She recently gave a presentation to the members of our Family Law Section on "Appellate Advocacy" where she made an otherwise esoteric topic easy to understand and less intimidating for those of us who never step foot in the Appellate Courts. Her ability to empathize with litigants, and to guide them through the legal process in an understandable and efficient manner is an asset that I see Ms. Copeland bringing to the Family Court bench.

She has also been an active member in the bar association and has given many pro bono hours to assisting the underserved in the community. She is heavily involved in public service.
