Members reported that the Nominee has shown a dedication to honoring the principles of Due Process and civility in all aspects of practice. She is always prepared, does well on her feet and does not shy away from trials. She is excellent in problem solving and will be an asset in facilitating negotiations and compromises with sensitivity and practicality. The Nominee has been described as a "navigator" with vision who will not be stagnant, will innovate and be helpful to the administration of the District Court.

The Nominee has volunteered for the Young Lawyers Division Junior Judges program where volunteer attorneys go into grade 4-6 classrooms and raise current hypothetical scenarios which may challenge their ability to distinguish between right and wrong.

Ms. Fukui's philosophy of moving cases along keeping in mind Due Process principles will serve her well on the District Court bench in view of the increased workload due to the COVID pandemic. Testimony of HSBA JC2 Hearing on October 1, 2020 Page 3
