Dear Chief Justice:

I write in support of my colleague and friend, Elizabeth Paek-Harris, to be appointed as a full-time judge to the Family Court of the First Circuit.

I have known Elizabeth since our student days at William S. Richardson School of Law. As a general practitioner, who handles some family court cases, I have consulted Elizabeth over the years whenever I had a question or issue about one of my divorce cases. Elizabeth or "Libby" as her friends sometimes refer to her, has always been generous with her time and has been a valuable resource in my own practice.

I cannot think of anyone more qualified than Elizabeth to be appointed to the family court bench for the following reasons:

First, Elizabeth is extremely knowledgeable about family law and is always up to date about the latest appellate decisions and amendments to the applicable rules. In part, this is because, Elizabeth has volunteered for years to update the Hawai'i Divorce Manual as a member of the HSBA's Family Law Section. In the past, whenever I had a question about some aspect of family law, I could always call Elizabeth to find out the answer or to point me in the right direction.

Second, Elizabeth embodies the spirit of community service, which our alma mater (i.e., WSRSL), instilled in us. Over the years, Elizabeth has selflessly committed countless hours to providing pro bono legal services, which she has been formally recognized for. Elizabeth is also a passionate advocate for animals and has been involved in the local community to help build dog parks and to protect the rights of abused animals. In the area of family law, I believe empathy and compassion for litigants is an essential attribute, only second to substantive knowledge of the law and the court rules.

Third, Elizabeth has an extremely wide variety of experience as a family law practitioner. In addition to having her own solo practice for many years, Elizabeth worked under William Darrah, Esq., who is one of, if not, the most highly regarded family law practitioner in our State, as well as the author of the Hawaii Divorce Manual. Elizabeth has also served as a per diem judge on the family court bench for the past few years. Elizabeth was also law clerk to the Hon. Steve Alm following law school. While I assume you have her CV in your file, I wanted to emphasize the fact that this diverse experience, ranging from working for a divorce attorney specializing in multi-millionaire divorces to handling pro bono divorce cases for indigent clients, gives Elizabeth a broad set of experiences and skills necessary to be a competent arbiter in family law cases.

Fourth, Elizabeth has a stellar reputation in the legal community in her role as a per diem judge. However, I often hear other family court attorneys and their clients praise her fairness in making decisions in their cases. I also have heard family law attorneys lament the fact that they were not able to get Judge Paek-Harris assigned to their case.

Finally, Elizabeth did not have an easy upbringing and overcame many personal challenges to achieve what she has in her career. In high school, Elizabeth essentially raised her younger sister while her mother worked full-time and helped out her family financially. I am a firm believer in the mantra that "what does not kill you makes you stronger." While I will not go into any more personal details, I believe the obstacles Elizabeth had to overcome to become an attorney has served her well and molded her character for the better.

In conclusion, with many experienced family law judges having recently retired from the bench, Elizabeth would not just be a valuable addition, but a necessary asset to our judiciary.

I know Ms. Paek-Harris well. I believe we were colleagues for her entire career as a family law attorney, which spanned several years. During that time, we worked together in at least two bench-bar committees. My most recent and salient work with Ms. Paek-Harris occurred during our almost-identical tenures as first-time *per diem* judges assigned to the Family Court of the First Circuit from February 2019 until February 2020. Not only did we serve at the same time, but we also shared chambers and saw each other almost every week during that year.

In every interaction with Ms. Paek-Harris, she has impressed me with her intelligence but even more with her conscientiousness, diligence, rational and objective thinking, and desire to do the right thing.

- As a family law attorney, Ms. Paek-Harris was a professional in the best sense. She was my opponent in several cases but was always courteous, well-prepared and meticulous. She advocated for her clients while inspiring me to be at my best.

Your comments: Dear Mr. Chairman and Members of the Judiciary Committee, My name is Michelle Moorhead and I am the Managing Attorney of the Family Law Division at the Legal Aid Society of Hawaii. I currently serve as the elected Chair of the Family Law Section of the Hawaii State Bar Association. Notwithstanding these affiliations, I am writing to you in my personal capacity to support, endorse and recommend that the Honorable Elizabeth Paek-Harris be confirmed as a District Family Court Judge of the First Circuit. As this Committee may be well aware, Judge Paek-Harris has acted as regular per diem judge in the domestic division since her appointment as a per diem judge. It is my personal assessment that she been doing an excellent job working with both represented and unrepresented parties. I have heard positive feedback about her from colleagues in private practice and also my employees at Legal Aid (whose clients are self-represented litigants who have appeared before Judge Paek-Harris). Judge Paek-Harris has proven herself as a fair, impartial and competent judge. In 2013, I served as a legal extern for Mrs. Paek-Harris when she was practicing as a Family Law attorney.
