I fully support the confirmation of the Ms. Lesley N. Maloian Judicial Nominee, to the District Family Court of the First Circuit.

I have known Ms. Maloian since 2003 when she joined the Office of the Public Defender. Ms. Maloian is highly qualified to serve on the family district court bench. She holds herself to high standards of preparation and performance. She is well respected by the judges and the prosecutors for her professionalism, integrity, and courtroom litigation skills. She not only has the intellect to grasp complex legal issues, but she also has the ability to articulate and explain her analysis in a thoughtful, thorough, and intelligent manner.

Because district family court judges preside over people dealing with very personal family matters on a daily basis, the judicial applicant must have the judicial temperament, demeanor, and character to be successful. I know that Ms. Maloian will treat each individual -- including attorneys, litigants, and witnesses -- with dignity, patience, respect, and compassion. Indeed, many of the family court participants (i.e., spouses appearing for divorce proceedings, hopeful parents appearing for adoption proceedings, parents/guardians and children appearing before Child Protective Service hearings, minors and parents appearing before juvenile delinquent hearings) -- are unfamiliar with and are intimidated by the judicial system. Ms. Maloian, with her "down-to-earth" personality, will put them at ease. And she will be such a positive influence on the children and teenagers, especially the girls and young women, who appear before her in juvenile delinquency proceedings. I am certain she will help and inspire the juveniles with her enthusiasm and positive energy.

District and family court judges must also possess a strong work ethic, good common sense, and practical judgment. They must also be efficient and organized to manage

the voluminous and demanding workload. Having worked closely with Ms. Maloian, I can say without reservation that she possesses such qualities.

Ms. Maloian has always been generous with her time to help, mentor, and counsel the less experienced attorneys in the office as well as our law school and college interns. She has invited the less experienced attorneys and law school interns to second chair her jury trials. She would take the time to involve the second chairs in the trial process (pre- and post-trial) rather than simply have them sit at counsel table. Because of her generosity and her willingness to mentor young people, she will be an outstanding judge, as the District Court and the District Family Court criminal/juvenile divisions are often staffed with inexperienced prosecutors and deputy public defenders. Prior to joining the Office of the Public Defender, Ms. Maloian was an associate attorney in a Honolulu family law practice and was employed as a deputy public guardian with the Cook County Office of the Public Guardian.

As long as I have known Ms. Maloian, she has practiced law with competence, zealousness, compassion, integrity, and humility. She has demonstrated that she possesses the ability, the experience, and the intellect to a district family court judge or a district court judge. - Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Maloian on July 21, 2021 to discuss the subcommittee's findings. On July 22nd, Ms. Maloian was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Maloian was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Maloian in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- · Financial responsibility
- Public service
- Health
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Appointee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Ms. Maloian's professional development as an attorney has not been traditional or linear. She was employed by the City of Chicago in the Department of Buildings as an administrative hearings officer. Thereafter she was employed in the Cook County Office of Public Guardian as Deputy Public Guardian where she was responsible for all facets of litigation, and placement and administrative hearings. Ms. Maloian was an attorney in a small Honolulu firm handling family cases including divorce and paternity issues.

Lesley Maloian has been a valued attorney in the Office of the Public Defender since 2003. During her tenure in this high-volume caseload government agency, Ms. Maloian has proven herself to be a respected trial attorney who is known to be organized, diligent, fair, detail oriented, intelligent, and who now serves as a mentor to less experienced attorneys. She is known for her knowledge of the law, strong legal research skills and has litigated cases in District, Family and Circuit Court ranging from abuse of a household member to murder in the second degree.

In addition to a varied professional background, Ms. Maloian's philosophy of treating everyone with respect, compassion and empathy, and her commitment to public service has prepared her for a seat on the State bench.
