- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the Nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Ms. Jill M. Hasegawa on June 13, 2022 to discuss the subcommittee's findings. On June 14th, Ms. Hasegawa was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Ms. Hasegawa was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Ms. Hasegawa in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Judicial Appointee Jill Hasegawa was born and raised in Hilo. After graduating from the William S. Richardson School of Law, Ms. Hasegawa began her legal career at the law firm of Ashford and Wriston specializing in Family Law. She also serviced financial institution clients, and handled collections, foreclosures, and other civil legal matters. She was made partner in 2013. In 2017, Ms. Hasegawa left the firm to relocate back to Hilo and began practicing law with her father. Since 2020 Ms. Hasegawa has served as a Third Circuit Per Diem Judge.

As a Per Diem Judge in Kona Waimea and Hilo, Ms. Hasegawa has presided over District Court Criminal, Family Court Criminal, District Court Civil cases. She has also presided over an extensive Family Court calendar including, divorce, paternity, juvenile, child welfare, guardianship, adoption, TROs, and civil involuntary commitment proceedings.

Ms. Hasegawa has an extensive pro bono public service record which includes appointment to the Access to Justice Commission, training attorneys with the Domestic Violence Action Center and taking DVAC cases, and volunteering with Volunteer Legal Services of Hawaii and with the Court Annexed Arbitration Program.
