Good Morning Chair Rhoads, Vice Chair Keohokalole and Members of the Committee:

I strongly support the Chief Justice's nomination of Greg Meyers to be a district judge of the Fifth Circuit, where he will be assigned to Family Court.

I have only known Greg for about a year, but under circumstances which provide good insight into his qualifications: he and I have been opposing counsel in a bitter divorce case which recently culminated in a five-day trial in Lihue. You come to know someone well in those circumstances.

I am happy to report that my experience has been that Greg has been unfailingly civil and professional throughout. While we have taken opposing positions, he has a good knowledge of family law and procedure, and I have always found him to be reasonable (his client, less so). While we were unable to reach a settlement in the case, it was not for his lack of trying (nor mine) and we were able to make some agreements as well as find ways to reduce the costs to our clients and expedite the business of the court. He was not the first attorney on that case, and he was certainly a welcome change from his predecessor.

All things being equal, a competent, reasonable and professional family court practitioner is usually a pretty good pick for family court judge. I can predict with confidence that Greg will hit the ground running, and there won't be much of a learning curve.

Honorable Members of the Senate Judiciary Committee,

I am writing to express my support for Gregory Meyers for the position of judge in the District Family Court of the Fifth Circuit. I have known Mr. Meyers since 2003, when I arrived on Kauai to work at the Kauai Office of the Prosecuting Attorney. At that time, he was working as the Managing Attorney at Legal Aid on Kauai, and although I did not interact with him much for my first few years there, I was very aware that he gained a solid reputation very quickly as a passionate advocate for the indigent in Family Court and District Court matters. Kaua'i is a small island, and his compassion and empathy for those who could not otherwise fight for themselves became well-known.

When I began working in what was then known as the Family Support Division of the Kaua'i County Attorney's Office, I had more interaction with Legal Aid, as many parties involved in the Family Support Division were also receiving representation from Legal Aid. I saw firsthand how under Greg's leadership Legal Aid acquired more resources to expand and provide much-needed access to justice for its clientele. On an island where a disproportionately high amount of the population routinely qualifies for indigent and public services such as those provided by Legal Aid, such access is crucial for those who are in desperate need of such services but who cannot afford it. Remarkably, Greg ensured that Legal Aid kept pace with the ever-growing need for their services and established a solid foundation that has allowed his successors to continue serving the island well to this day.

When he went on to form a law firm, I was working at the Kauai Office of the Prosecuting Attorney for a second time and I began to have regular direct interaction with him in the District and Circuit Courts of the Fifth Circuit. We had our share of complex criminal cases, each with many moving parts and novel issues, and Greg was always highly knowledgeable of caselaw and statutes. He zealously and unceasingly advocated for his criminal clients, but always did so by the book. There were never any cheap shots or ambushes; he expected the State to comply with the rules of Court, and he adhered to that same standard for himself inside and outside the courtroom.

Just as he was in his criminal cases, he was always well-prepared, zealous, yet tempered with realistic approaches, and could always be counted on to be fully candid with the Court and opposing counsel. We have crossed swords many, many times over the years, and without a doubt we have had many heated interactions in chambers and in the courtroom. At one point we happened to have so many highly contentious cases against each other that we noticed over time that the Court was calling our cases at the very end of the calendar for each session; we half-joked that the Court was fed up with our constant arguing and did not want to deal with us until the end of the day.

Yet even through these most truly wrenching and contested of our cases with each other, Greg always behaved ethically and never deviated from the rules of civility among attorneys. I have never seen him lose his temper, and never saw him behave unprofessionally. There is one particular instance which stands out among all others in my memory, and it when Greg really embodied the rules of civility while still maintaining advocacy for his client. We were in the middle of a truly contentious and heated trial while I was far along in a high-risk pregnancy. At the beginning of one of our trial days, I began experiencing pregnancy-related complications right there in the courthouse, and I told Greg that I could not proceed any further on that day. He would have been well within his rights as an advocate for his client to react vociferously and prolong the situation while knowing that I was in a limited capacity to fight back, but he immediately worked with me to establish concessions which were favorable for both our clients and which allowed me to leave and seek medical treatment right away. (Greg went on to prevail in that matter when we concluded the trial).

Greg can always be counted on to pretty much know the Rules of Professional Responsibility verbatim, and he adheres strictly to them. Indeed, over the years I would sometimes reach out and ask him for advice if I was facing an ethical dilemma in a particular case, and his perspective was always sound.

He is clearly comfortable and beyond knowledgeable in both Family civil and all types of criminal matters. In fact, about two years ago I handled an appeal for a case in which he was the trial attorney; the impressive foundation he laid throughout the entirety of the pre-trial and trial proceedings—which spanned years—allowed for a meritorious appeal, which the Hawai'i Supreme Court found in favor of, resulting in the complete vacating of our mutual client's felony convictions in a published opinion. His work in that matter is reflective of the quality and persistence and thoroughness with which he approaches all of his cases, whether in the family court, criminal court, or civil court. It is worth noting that he was just very recently in the newspaper for yet another successful

appeal, this time in the area of Child Welfare Services; this particular appeal is ground-breaking and has far-reaching implications in this particular area of Family law.

As a regular practitioner primarily in both the Kauai and Oahu Family Courts, as well as in other courts across the islands, I respectfully offer my opinion that Greg Meyers would be a tremendous as well as much-needed asset on Kauai, and a truly qualified judge. The distinct advantage to having him as a Family Court judge is that there would be no learning curve with him; Mr. Meyers has the knowledge, skills, and also the temperament to effectively run the courtroom literally from day one, across all dockets: criminal, divorce, juvenile, paternity, guardianship, child welfare, etc. I believe this is an absolutely crucial requirement that must be taken into consideration given the backlog of cases in the Kauai Family Court, and the unique needs, demographics, and characteristics of the community on Kauai. Mr. Meyers is very much in tune with the community and volunteers himself extensively in both law- and non-law-related community groups and activities. 



- Submittal of a report by the three-person review subcommittee to the President, and subsequently to the entire Board.
- Meeting of the President, the Executive Director, and the Nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board to determine if the nominees is qualified or unqualified.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Executive Director met with Mr. Gregory Meyers on June 13, 2022 to discuss the subcommittee's findings. On June 14th, Mr. Meyers was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Mr. Meyers was reviewed and the references listed were contacted for their personal opinions and observations. The categories of the HSBA criteria used include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position

The task of the HSBA was to determine the qualifications and suitability of the Nominee utilizing in large part, the judicial appointments criteria of the American Bar Association. The criteria are not ranked in terms of importance as it is used universally to review the qualifications of appointees for trial and appellate positions. The determination of qualified or unqualified is based on a totality of the documentation received, member and reference comments, and the interview of the individual appointed.

Greg Meyers began his legal career in Hawaii as an AmeriCorps attorney with the Hilo Legal Aid Society of Hawaii (LASH). He was then appointed as Managing attorney for the LASH Kauai office. At the LASH, the Nominee focused on public benefits work assisting clients with welfare, general assistance, disability, and unemployment benefits. He handled family cases involving paternity, custody and visitation, guardianships, adoption, child support, and civil cases involving landlord-tenant and consumer issues. He also started the Equal Justice Center for low income pro se litigants and provided community outreach and educational seminars.

As an attorney in private practice, Mr. Meyers gained experience in complex civil litigation including contract disputes, derivative lawsuits, commercial lease negotiations, wills and estates, real estate and property disputes, products liability, fraud and misrepresentation, wrongful death, and civil rights litigation.

Mr. Meyers has served as a per diem family judge for the Fifth Circuit presiding over divorce, custody, child support, adoption, guardianship, involuntary hospitalization cases and all other civil family matters. The Nominee is currently a partner in a firm which specializes in family law, criminal defense, civil litigation, personal injury, and administrative law.

The Nominee has significant contacts with the broader Kauai community outside the practice of law. Kauai organizations the Nominee has or is currently participating in include Junior Achievement, Hale Opio (nonprofit dedicated to nurturing Kauai youth), Hoike Community Television, Niumalu Outrigger Canoe Club, and the Garden Isle Arts Council.
