As I was beginning to author an exceptionally strong endorsement of Judge **BROWN**, I received your email, and was so incredibly impressed. Like teammates ----- something Judge **BROWN** knows all about as a stellar former High School & NCAA athlete [who, by the way in my humble opinion, still looks as if he should be on the field ----- [redacted] is coming together to support one of its own, and its leader at that!! Teammates supporting & celebrating another teammate. That's BIG TIME in my humble view.

IF I may be so bold to kinda "add-on" to your email, [redacted]. Many exceptionally famed attorneys on this e-blast string make their living in Family Court, as have I for the last about 36 years. Based on this reality, I simply want to share that I have appeared before Judge **BROWN** many times since "someone" was smart enough to place him on the bench. I have no say, and won't, BUT in my personal (& professional) view, I firmly believe no Judge should take the bench without first having about 5 or so years of significant litigation, "in the Courtroom" experience. Let me tell you, Judge **BROWN** is perhaps one of the finest at being able to properly & effectively control his Courtroom. His knowledge of Courtroom procedure & the Rules of Evidence are truly unmatched. #### **Dear Senators:**

I have known RJ since we were 15. I have known him as a friend, classmate (first in high school, then later in law school), an attorney, and now a colleague. More than that, I have known him as a teenager, college student, football player, husband, and father.

RJ and I first became friends because our friend group overlapped. But, we really became close our senior year of high school when we both were in a current events class. The teacher we had was unique, and she would often have us watch a news clip or read an article and then ask openended questions (knowing full well that there would be *heated* opinions on the matter). RJ and I were often at opposite ends of the debate spectrum, but we learned early on how to listen and try to understand where the other side was coming from.

In college, our wide-ranging debates continued, often via a random social media platform. Again, no matter how heated the arguments, RJ always listened to the other side, researched the issue, and respectfully countered with his own position. Our debates continued years later in person, when we ended up in the same law school class at UH Manoa.

I was thrilled to watch RJ thrive after law school at the Prosecutor's office. I was even more excited when RJ decided he wanted to do something different, and move into private practice. Working with him as a colleague over the past five years has been a full-circle experience and reiterated what I already knew: (1) RJ is incredibly smart, and can easily learn and understand complex legal issues; (2) he is an excellent writer, and someone that we can always lean on to knock out a complex brief; (3) he is fair, and while always advocating for the clients he needs to advocate for, is cognizant of not overstating his case; and (4) he is amazing with people –RJ has an innate ability to respectfully listen and make sure people feel like they have been heard. This is true of colleagues, clients, and opposing counsel. I believe these qualities are the exact type that are needed for judges.

RJ's recent work as a per diem judge has been so rewarding for him, and I know he takes the responsibility and the work seriously. There is no doubt in my mind that he is taking the time to prepare, listen, and evaluate each case that comes before him with the utmost care. There should not be any concern that RJ is too young or too inexperienced, his work ethic and judgment speak for themselves.

RJ is someone who I can lean on for any problem, legal or otherwise, and I know that he will provide thoughtful and respectful feedback, even if he disagrees. He does not hesitate to share his opinion or make a decision, but he always does so in a respectful manner. It goes without saying that I believe RJ would be an excellent addition to the judiciary.

RJ is currently in the private practice of law and a per diem judge for the Family Court of the First Circuit. As a per diem Family Court judge, the Nominee has presided over matters pertaining to temporary restraining orders, paternity, custody, divorce, and Drug Court. As a civil practitioner in the private practice of law, the Nominee specializes in commercial and real estate litigation. He is also an Adjunct Professor at the William S. Richardson School of Law.

The Nominee is known for his unwavering integrity, diligence, and deep commitment to make a positive impact in all endeavors he undertakes. It was reported that as a Deputy Prosecutor, the Nominee focused on doing what was right for the parties and social justice.
