# In consideration of Governor's Message No. 1

Chair Rhoads, Vice Chair Gabbard, and members of the Senate Committee on Judiciary:

I respectfully ask for your favorable consideration of Governor's Message No. 1, the appointment of Lisa M. Ginoza as an Associate Justice to the Hawai'i Supreme Court.

Judge Ginoza currently serves as Chief Judge for the Intermediate Court of Appeals, a position she has held since being sworn in on April 24, 2018. Prior to her appointment as Chief Judge, she served as an Associate Judge of the Intermediate Court of Appeals since May 6, 2010. Additionally, Judge Ginoza served as the First Deputy Attorney General for the State of Hawai'i from 2005 through 2010. In her capacity as First Deputy Attorney General, she helped to assist the Attorney General in leading their department of more than 700 employees across 16 legal services divisions and five non-legal divisions.

Her private practice experience includes extensive work in civil litigation in her fourteen years at the law firm of McCorrison Miller Mukai MacKinnon, where she became a partner. She also is a member of the boards of directors of the Judiciary History Center and the American Judicature Society, chairs the Hawai'i Supreme Court's PACE Commission, and has served as an Adjunct Professor in Appellate Advocacy at the William S. Richardson School of Law. A graduate of Kailua High School and Oregon State University, Judge Ginoza earned her Juris Doctor from the University of Hawai'i at Mānoa William S. Richardson School of Law.

Chair Rhoads, Vice Chair Gabbard, and Members of the Committee:

My name is Martha Torney and I am pleased to submit this testimony is **strong support** of Judge Lisa Ginoza's gubernatorial nomination as Associate Justice to the Hawaii Supreme Court.

Given her tenure as a member of the Intermediate Court of Appeals since 2010 and Chief Judge since 2018, her record is rich with published opinions that allow you a clear picture of her thinking when deciding a case, always most logical and well-documented. My experience with Judge Ginoza precedes her appointment to the Court and provides me with an opportunity to share the incredible support she provided as the State of Hawaii responded to a Settlement Agreement with the US Department of Justice over conditions at the Hawaii Youth Correctional Facility.

Between 2006 and 2010, I worked very closely with Judge Ginoza during my tenure as Executive Director of the Office of Youth Services (OYS). I have no question that she possesses the impeccable character, unquestioned integrity and intelligence required to be a member of Hawaii's highest court.

In February 2006 the State of Hawaii entered into a Memorandum of Agreement (MOA) with the US Department of Justice (DOJ) concerning conditions of confinement at the Hawaii Youth Correctional Facility (HYCF). Just two weeks earlier I joined OYS to assist in addressing the terms of the agreement and had the unmitigated luck to work closely over the next four years with then First Deputy Attorney General Ginoza in responding to the MOA.

It was Judge Ginoza who negotiated the terms of the settlement with DOJ and her continued involvement ensured a deep understanding of what was expected from the State to resolve the serious issues that led to the suit filed on behalf of the wards. Most important was her ability to forge a collaborative relationship with the DOJ attorneys based on mutual trust while not abandoning her responsibility to represent the State's interests. Potential conflicts were identified as they emerged and immediately dealt with

before they became impediments to achieving compliance with the MOA provisions. The relationship was certainly tested at times yet Judge Ginoza was always able to forge resolutions in a fair and cooperative manner.

OYS required the help and support of many other State departments to comply with the terms of the MOA and Judge Ginoza would make herself available to accompany me to meetings with leadership as we asked for their cooperation and assistance in addressing the myriad of bureaucratic problems that would sometimes impede progress at HYCF. She was always fair and considerate of the needs of others which resulted in solutions that were acceptable to all, allowing us to move forward.

Such solutions would not be feasible without the legal knowledge, understanding and diligence she exhibited in her actions on OYS's behalf. Clearly, Judge Ginoza was well acquainted with the constitutional issues that resulted in the DOJ lawsuit and represented the State of Hawaii well. But what sticks with me was her ability to grasp how those issues impacted the daily operations of HYCF and understanding of what was required by all involved to resolve them. Well respected by facility staff, she aptly conveyed how complying with the terms of the MOA would not only benefit the incarcerated youth but also improve working conditions. This tact help win over staff and garner their willingness to be part of the solution, not the problem. Perhaps Judge Ginoza's best attribute was her even temper and ability to remain calm under tremendous pressure.

Judge Ginoza is diligent and hardworking, possesses high ethical standards, and is one of the most compassionate people I know. Hawaii will be well-served to have her join the other justices on the Hawaii Supreme Court.

Chair Rhoads, Vice Chair Gabbard, and Members of the Committee,

My name is Zachery Morris, and I am Deputy Legal Director for State Courts at Alliance for Justice, a national association representing over 150 public interest and civil rights organizations. Since 1979, we have been a leader in advocating for a fair and independent judiciary that preserves access to the courts.

Alliance for Justice offers comments for this hearing regarding the importance of ensuring that the Hawai'i Supreme Court reflects the diversity of the populations it serves—both demographically and professionally—given our perspective on state supreme courts throughout the country.

Nationwide, nearly two out of every five justices on our state supreme courts have a prosecutorial background. Meanwhile, only about one out of every ten has background as a public defender. Out of 345 state supreme court justices nationwide, fewer than 25 have a background in civil rights, and barely 3% of state supreme court justices have backgrounds in civil rights law outside of government practice.

The perspectives of attorneys from public interest backgrounds—with experience ranging across public defense, civil rights, legal aid, labor law, reproductive justice, and LGBTQ law—bring invaluable experience that strengthens our courts. It is significant that we have one former public defender on the Hawai'i Supreme Court, and there is no shortage of eminently talented attorneys in the state who are well-equipped to continue adding further professional diversity to the court. In particular, issues of environmental law are as urgent as ever across the country, and specifically in Hawai'i, and will only continue to grow more pressing. Yet attorneys with environmental law backgrounds are close to fully absent on our state supreme courts.

Our justice system is founded on the belief that truth is borne of diverse perspectives. Maintaining a judiciary that understands how to weigh complex issues with the interests of marginalized populations in mind makes these considerations paramount. This extends to demographic diversity in addition to professional diversity. According to the US Census, Hawai'i has the single most demographically diverse state population in the country, and the makeup of its supreme court should reflect that.



We at Alliance for Justice, like all of you, are working to build a fair and just judiciary that upholds the principles of democracy for everyone. Accordingly, we encourage you to ensure that the Hawai'i judiciary, starting with the supreme court, serves as a model of demographic and professional diversity for states around the country to follow. We are in the midst of a precarious moment for democracy, and state supreme courts serve as bulwarks for our fundamental rights. But where state supreme courts lack professional diversity, and where courts don't look like the people they serve, they consistently fall short and side with those already in power.

The people of Hawai'i deserve true diversity on their supreme court, and today is an important opportunity to continue moving forward toward that goal. Thank you for the opportunity to testify.

Chair Rhoads, Vice Chair Gabbard, and Members of the Committee,

I am responding to your Notice of Hearing, and I respectfully submit this testimony in strong support of the Governor's nomination of Judge Lisa M. Ginoza to be an Associate Justice of the Supreme Court. $^{\rm 1}$ 

I am a judge on the United States Court of Appeals for the Ninth Circuit.<sup>2</sup> I served eight years as the attorney general of the State of Hawaii. I first worked with Judge Ginoza shortly after I joined the law firm that is now McCorriston Miller Mukai MacKinnon. We were colleagues at the firm for more than ten years. We worked together on many cases and co-tried one federal court case. Judge Ginoza was an exceptional lawyer. Her standout qualities—great legal skill, the highest possible ethical standards, and an outstanding work ethic. And in addition, Judge Ginoza was a wonderful colleague.

In 2005, after I had been attorney general for several years, the position of First Deputy Attorney General became vacant (after the incumbent became a Circuit Court judge). It goes without saying that that was an important position, particularly to me as the attorney general. I needed someone who had all the qualities I listed above. My first choice was Judge Ginoza, and I was very happy she accepted the position.

My faith in Judge Ginoza was fully justified, and more. She was an exceptional lawyer, personally handling some of the hardest cases in the office. She was also a great administrator, and a calm, thoughtful advisor to many executive departments. Time and again, I was told from those inside and outside the Department of the Attorney General—"We are so fortunate Lisa is the First Deputy."

Judge Ginoza handled the most stressful situations calmly, but resolutely. Judge Ginoza was always respectful of others and was highly respected by colleagues and opposing counsel.

I believe it was these qualities that caused Governors Lingle and Ige to nominate Judge Ginoza as an Associate Judge and then Chief Judge of the Intermediate Court of Appeals.<sup>3</sup> Her reputation as a judge is the highest possible—and for good reason. She is thoughtful, hard—working, and diligent, always striving as all judges should strive—to apply the law faithfully and correctly.

I cannot sum up Judge Ginoza's qualities better than the Senate Judiciary Committee did when recommending her confirmation as Chief Judge of the Intermediate Court of Appeals to the full Senate:

Testimony submitted in support of Judge Ginoza's appointment commend the strength of her reasoning and the clarity of her decisions. As an Associate Judge of the Intermediate Court of Appeals, her written decisions are thoroughly researched, well-reasoned, and logically presented. Numerous testifiers praised her leadership abilities, strong work ethic, integrity, and commitment to fair and sound decision-making. In addition to her judicial qualifications, Judge Ginoza has also demonstrated strong administrative skill in her role as First Deputy Attorney General.

Your Committee finds that, based on the testimony submitted on her behalf, Judge Lisa M. Ginoza has the experience, temperament, judiciousness, and other competencies to be the Chief Judge of the Intermediate Appellate Court, and has the broad legal expertise, superb character, outstanding judicial temperament, and unwavering commitment to justice that are essential for a Chief Judge.<sup>4</sup>

I believe Judge Ginoza would be an outstanding Justice on the Supreme Court. She has had experience with every type of issue the Supreme Court would face. She would hit the ground running. She would bring her exceptional ethics, skill, diligence, and temperament to the Court.

I respectfully ask the Committee on Judiciary to recommend to the full Senate that the Senate confirm Lisa M. Ginoza to be an Associate Justice of the Supreme Court.

She was always respectful, prompt and appropriate. Trial judges do not always have the luxury of presiding over a trial in which the trial lawyers act with civility and competency. In this trial, I must say that Lisa Ginoza's brief writing was excellent. She was always forthright, trustworthy and honest. If she didn't know something or had not done something, she would say so. When in a corner, she did not throw anyone under the bus. (If you have ever been in a contentious jury trial, you will know that there are many opportunities and encouragements to do so.) This says a lot about Lisa Ginoza's character and integrity.

It's easy to be nice and gracious when the going is good. It's when the going gets tough that we really have a window into someone's soul. Chief Judge Ginoza itook on the tough job of Chief Judge of the Intermediate Court of Appeals and served the court and the community admirably. We have had the chance to watch her grow and learn on the job as well as contribute her many skills toward improving the court's work product.

Hawaii Women Lawyers ("HWL") respectfully submits testimony in **support** of the nomination of LISA M. GINOZA to **the Hawaii Supreme Court** as Associate Justice for a term of 10 years.

HWL is a nonprofit organization with members including approximately 300 attorneys. HWL's mission includes improving the status of women in the legal profession, increasing the number of women attorneys in positions of authority and responsibility, and promoting the advancement of all women.

Increasing opportunities for qualified women in the Judiciary is extremely important. As highlighted by the World Justice Project, the rule of law depends on having justice delivered by "competent, ethical, and independent representatives and neutrals who reflect the makeup of the communities they serve. HWL believes that increasing opportunities for, and improving the visibility of, qualified women in the Judiciary is vital. The judicial bench should be adequately balanced and reflect the composition of Hawaii's citizens. Noting that the HSBA has found Judge Ginoza to be qualified for the position of Associate Justice and for the reasons above, HWL supports the nomination of Judge Ginoza.

You may recall that I previously wrote in wholehearted support of the Honorable Lisa M. Ginoza ("Justice Ginoza") for confirmation as Associate Justice of the Intermediate Court of Appeals for the State of Hawai'i. It is my honor and pleasure to now write in full support to confirm Justice Ginoza to become a Justice of the Supreme Court of Hawai'i.

I have known Justice Ginoza since she was a child growing up in Kailua. I was close friends with her brother Garrett, deceased. We played in community sports leagues, baseball, and football, together from the early 1970s through the early 1980s. We remained friends until his recent passing.

One of my most painful memories growing up was of the three Ginoza siblings losing their mom to cancer. I would often visit and play at the family home in Keolu Hills. Their mom was one of the most loving, caring, and active parents. She went to Heaven when we were all just kids. Justice Ginoza was still in grade school at the time.

After this tragic loss, I continued to visit their family home. Shortly thereafter, their dad moved to a different street in Enchanted Lakes. While we never discussed it, I think their dad had a very hard time after losing his wife and having to raise three young kids by himself. Their home was never the same after that.

In 1972, I began going to school in town and Justice Ginoza and her siblings went to Kailua High School. Even though we went to different schools, we remained in touch through sports. Justice Ginoza was a student-athlete above and beyond. She was the pride of Kailua. Although I did not physically see her report cards, the word was that her GPA exceeded 4.0, and she was an all-star softball player. She overcame the adversity and all the obstacles and challenges of losing her mother at a very early age.

While we have never socialized, we are very friendly when we see each other because we truly grew up together from small kid time. I strongly believe that your upbringing and how you were raised speaks volumes about who you are and will become in your later years. For the many years I have known her, I have only heard the most positive comments about Justice Ginoza.

All of the ingredients that made her successful in her youth have carried over into and applied to her professional life. She is very smart, competent, hardworking, a team player, and knows and has wisdom and aloha for our community. Our legal and community at large will be very fortunate to have Justice Ginoza as a Supreme Court Justice. .
