Dear Chair Rhoads, Vice-Chair Gabbard and Members of the Senate Committee on Judiciary:

I write in strong support of your recommendation of advice and consent of GM 2 Vladimir P. Devens ("Vlad") as Associate Justice to the Hawai'i Supreme Court.

It is an honor and privilege to submit my testimony and appear before you at his confirmation hearing. It is especially an honor to see so many of you who I have served with in the past.

As many of you are aware, I have sat where you are now. I know you take very seriously the Constitutional mandate of advice and consent and will do so with the nomination of Vlad. The American Bar Association has listed eight (8) criteria in the consideration of a judicial nominee. They are integrity, legal knowledge and ability, professional experience, judicial temperament, diligence, health, financial responsibility, and public service. From Vlad's resume you can be assured that he solidly meets each of the criteria.

It is unfortunate that some have raised the issue of whether Vlad's lack of judicial experience becomes a disqualifying factor for a nomination to the State's highest court. It does not; and in fact, I believe some confuse "judicial temperament" with judicial experience. I know when I sat on this Committee, "judicial temperament" was probably the most difficult criteria to assess. Over the years, I have concluded that you know when someone has the proper judicial temperament. It is defined by the ABA as "common sense, compassion, decisiveness, firmness, humility, open-mindedness, patience, tact and understanding." Vlad has these traits. In fact, one of the primary reasons why I believe he should be on the Supreme Court is due to these traits.

The balanced composition of the members of the Hawai'i Supreme Court is of great importance to me. I believe that the people of this State benefit when the three co-equal branches of government are functioning well and performing their respective constitutional mandates.

My support for Vlad is because I find the present composition of the Court lacks a Justice who understands administrative procedures and appreciates the duties of the Legislature and the Administration. Administrative procedures are how the public most often interfaces with government. This is why, I believe, so many of the United States Supreme Court Justices come from the D.C. Circuit Court and Court of Appeals. Most administrative challenges to decisions of any President's administration are decided by the D.C. Circuit Court and Court of Appeals. Currently, four (4) of the nine (9) Justices find their genesis in the DC Courts. Then add Ruth Bader Ginsberg and Antonin Scalia, two dominant members of the Supreme Court who also share that beginning. The DC Courts probably decide the most constitutional challenges to the laws of this nation.

As such, I believe that our Hawai`i Supreme Court needs a Justice who understands and has had the experience of representing parties before various agencies or has sat as a member of Board or Commission that decides contested cases. This is why one needs to have the traits of judicial temperament as defined by the ABA. Vlad is such a person and has the necessary experience. It is important to note that for many of our constituents, when they challenge the government's decision, it is more than likely through a contested case hearing. The administrative procedures were drafted so an individual could make a challenge without the assistance of an attorney. To evaluate and assess as to whether the intent of the law has been followed, it is necessary to have a Justice who knows this process and has common sense, compassion, patience and understanding, to name a few traits.

Some of the most critical cases for this State began as administrative appeals. The most notable is the two decisions regarding the Thirty Meter Telescope. I anticipate that the Maui/Lahaina Fires will bring issues before the Public Utilities Commission which is also an administrative process.

I am not ignoring Vlad's accomplishments and his reputation as a litigator and great advocate. Many who were before the JSC and the Governor for consideration have similar credentials. My support for Vlad is not only for his great skills as a litigation; but because he uniquely fills a void that I find in the Court.

Let there be no mistake, Vlad has shown his superb ability as a litigator and an advocate for the thirty-five (35) plus years that he has been a member of the Hawai'i Bar. He has also shown his commitment to the profession by serving as a member of the Bar Association during a time when the United States Supreme Court was deciding cases that could affect the ability of the Hawai'i Supreme Court and Bar Association to function as it does. He also represented public sector unions when their existence was and continues to be challenged by the *Janus* decision and its progeny. This challenge goes to the essence of *Hawai'i Revised Statutes* Chapter 89 and Article XIII of the *Constitution of the State of Hawai'i*.

Dear Members of the Hawaii State Senate Judiciary Committee,

My name is Jim Takatsuka. I work in the technology sector and am a lifelong resident of Honolulu. I write in support of the nomination of Vladimir Devens to a seat on the Supreme Court of the State of Hawaii.

I have known Vlad for nearly my entire life. We grew up in the same neighborhood, were college roommates at UC Berkeley and have remained friends for over 50 years. Since I do not work in the legal field, I will leave it to others more qualified than I to speak to Vlad's legal acumen. However, I do feel I can speak to his character, as he clearly possesses qualities consistent with the judicial temperament of a supreme court justice.

Even at a university with the academic standing of UC Berkeley, I have not met anyone as intellectually gifted as Vlad. And yet in his encounters with people and situations, he always leads with a sincere humility and curiosity, an embodiment of what's often called "the beginner's mindset". He always seeks to learn first, to understand first, before formulating any opinion or taking any action.

In his interactions with others, Vlad's authenticity shines through. He puts on no airs, no pretenses, and doesn't prioritize the wealth, credentials or social status of those he meets. He enjoys seeing people as they are, interested in what they do and what they think, and always respects them for who and what they are.

After graduating from the UC Berkeley School of Law, one of the most prestigious law schools in the country, and shortly thereafter passing the Hawaii State Bar Exam, Vlad chose to join the Honolulu Police Department, despite having a number of options for going into private practice. When I teased him about the fact that he was passing on a good salary, Vlad replied that the money wasn't important. He was more interested in learning how the law worked and was excited that HPD gave him the opportunity to see the law from different perspective. It was a response that was at once a little surprising, and yet entirely consistent with the man I know.

I'll note that Vlad served in the HPD with distinction for many years. He effected multiple felony arrests and worked undercover, conferred with prosecutors on cases and judges on warrants, drafted a search and seizure operations manual for the department and provided instruction on the laws of arrest and the use of force for new officers. After leaving HPD and beginning his career in law, he even continued at the department as a reserve officer. Vlad's time as a police officer wasn't a token effort. His service there was sincere and his interest in the law genuine.

Vlad's professional and educational credentials are impressive, in my mind well qualifying him for a seat on the State Supreme Court bench, but I believe his humility, empathy and earnest curiosity truly distinguish him as an outstanding candidate for a seat on the Supreme Court of the State of Hawaii.

My name is Ilima-Lei Macfarlane and I <u>strongly</u> recommend Vladimir Devens to be our next Hawaii Supreme Court Justice.

I am a proud native Hawaiian born and raised in Hawaii. I make a living fighting professionally and held the flyweight championship belt for several years with Bellator MMA. However, I am most proud of my work with my foundation, Nā Wahine Toa (Women Warriors), which I founded to strengthen and empower native women by teaching self-defense, self-love, self-preservation and the protection of sacred sites including our bodies, our divine feminine entities and our 'āina. I strive to be an example to other Native women and to give them strength and inspiration, but this did not always come easily for me. Native women face an epidemic of violence and suffer the highest rate of sexual abuse. Unfortunately, I was also sexually abused as a child, and it took me many years to gather the courage to take back control of my life.

I was sexually abused as a child by one of my basketball coaches in a well-known case that I am sure you heard of. At first, I did not have the courage to file my lawsuit let alone publicize my name and childhood trauma. With help, I built up the strength to be vulnerable, to confront my truth, and to stand up for myself, and I give credit for that to my attorney Vladimir Devens. He was more than an attorney to me, my sister who was also a victim, and to the other girls victimized by the same predator coach. Vlad listened, he was compassionate, and he allowed us to move at a pace that we were comfortable with. He explained the process in scrupulous detail, stood by our sides during the most difficult phases of litigation, and was our strength as we re-lived the worst days of our lives. Vlad treated me as if I were one of his three daughters and fought for us with the passion and fearlessness that we needed and longed for. He was our booming voice when for years we suffered in silence. Knowing Vlad changed my life for the better, and because of him, I will continue my fight to protect other native women from their abusers and the internal damage that they cause.

Dear Senator Rhoads,

Please accept this letter in support of Vladimir P. Devens' Senate confirmation as an Associate Justice to the Hawai'i Supreme Court.

I write specifically to provide you with my personal observations of his demonstrated judicial temperament, deportment and integrity while "sitting" as a "judge" in Hawai'i disciplinary matters. These observations are derived from his service since July 2017 as a member of the Supreme Court's Disciplinary Board.^[1] During that time I observed him while serving as both the Board's general counsel (until 2018) and as Chief Disciplinary Counsel (2018 to present).

As you know, the Disciplinary Board sits in both an adjudicative and administrative capacity in Hawai'i lawyer discipline matters. The Board reviews the findings and recommendations of formal hearings officers, and separately, individual Board members sit to review recommendations for disposition by the Office of Disciplinary Counsel (ODC) on individual

investigations. The Board hears and deliberates on numerous formal cases each year, and hundreds of ODC investigations are reviewed by the Reviewing Board Member (RBM) panelists.

While I was Board Counsel (until mid-2018) I observed Mr. Devens present or otherwise participate in the review and deliberation of a number of formal discipline cases. At all times I felt he did so with distinction and helped the Board to achieve a fair result.

More importantly, since my time as the ODC Chief, I have noted that Mr. Devens has regularly and consistently volunteered to serve as an RBM. The RBM function is to review ODC's reports of misconduct investigations, supported by relevant evidence and then to decide whether probable cause exists to bring charges, or whether in the exercise of prosecutorial discretion, the matter should be otherwise resolved. RBM findings are adjudicative orders.

Over the years, I have found that Mr. Devens' has consistently performed his RBM duties in a timely and appropriate manner. While we don't always agree (what lawyer always agrees with the judge?), I can say that in every case he has made a fair and just determination and has never shown disrespect or bias.

In sum, while a lawyer to most of the community, Vladimir P. Devens is a "sitting judge" over the ODC, and I have had this unique opportunity to observe his judicial temperament, deportment and integrity. These are qualities that he holds in abundance, and for which I am happy to lend my sincere endorsement and recommendation for appointment as an Associate Justice of the Hawai'i Supreme Court.

Chair Rhoads, Vice-Chair Gabbard and Members of the Senate Committee on Judiciary. I am writing to ask your support of the nomination and confirmation of VLADIMIR P. DEVENS as one of two Associate Justices to the Hawai'i Supreme Court.

I have been a practicing attorney in the State of Hawai'i for over forty-two years after graduating from the William S. Richardson School of Law in 1981. My practice is primarily civil litigation and I have had numerous cases with Mr. Devens. He has always been well prepared and knowledgeable on all aspects of his client's case and writes clear and logical briefs based on the law. He is articulate and well prepared when presenting oral arguments to the Court and opposing counsel. He has a broad breadth of experience in all areas of civil law and, in addition to his civil background, Mr. Devens has over 33 years of experience with criminal law and procedures.

For the last 24 years I have been and currently serve as a Director on the Hawaii State Bar Association (HSBA). I have served a Director of the Hawaii State Bar Association, and as Chair of the Bar's Special Committee on the Appellate Backlog, and was elected by members of the Bar to serve on the Judicial Selection Commission from 2009 to 2015, where I served as Vice Chair. I have tried numerous civil jury trials and have represented hundreds of injured or defrauded individuals and consumers over the years. 

It is my honor to submit this letter of recommendation in support of the nomination of Vladimir Devens to the Hawai'i Supreme Court.

I am an attorney licensed to practice in Alaska, Oregon, and Washington. My practice has emphasized the representation of public safety employees and their labor organizations. It is through that practice that I have become acquainted with Mr. Devens.

Beginning more than 30 years ago, Mr. Devens and I have worked together on a variety of projects in federal and state courts and in arbitration. Some of these projects have been quite complicated, including a Fair Labor Standards Act opt-in collective action involving more than 20 claims brought on behalf of over 2,000 employees of the City and County of Honolulu. On other occasions we have worked together on interest arbitration proceedings over the wages paid Hawai'i's police officers, proceedings where hundreds of millions of dollars have been at issue. Cases of this scale require considerable planning, dedication, and intensive preparation.

I have worked with Mr. Devens in a variety of litigation settings, from the complicated to the routine. I have observed him in court, in mediation, in informal settlement negotiations, interacting with clients, and in social situations.

I have been practicing law in this jurisdiction since 1991 and, early on in my career, I became familiar with Vlad's work and reputation as an attorney. Vlad's contributions to the JAC's work have been so valuable that he was eventually appointed to be and currently serves as one of the co-chairs of the JAC.

Now as an adult, he often expresses his passion to protect people who were unfairly treated and is willing to sacrifice time with his family and friends (working long hours 7 days a week) to work toward a just outcome and to ensure that they receive fair representation.

They have engrained and modeled the important values of honesty, hard work, honor, compassion, open-mindedness, respect, courtesy, humility, generosity, and fairness. I write this letter of support for Vladimir Devens, who is a Gubernatorial Nominee for the Hawaii Supreme Court. I have known Vlad for approximately 25 years. I know he started as an HPD officer, serving his community before he decided to practice law in Honolulu like his father and his sister. My first contact with him was many years ago when I was appointed as a Court Annexed Arbitration Program arbitrator for a personal injury case in which Vlad represented the injured plaintiff. The case went to hearing and the attorneys each presented their position on the case. I found Vlad to be well-prepared, articulate, and insightful. The case settled following the issuance of the arbitration award.

settlements that may not represent full or sufficient compensation for severely damaged clients. I saw Vlad reject early settlement offers on several occasions. I have known Vlad in a personal and professional capacity for approximately 55+ years. Vlad and I grew up in Aina Haina in the mid-1960s. Vlad was a frequent guest, as his sister, Paula (Judge Paula Devens), and my sister were best friends, he would visit because his sister was responsible for watching him, if she wanted to come over. Vlad was my attorney for a lawsuit I filed against my high school and my former basketball coach because he sexually abused me when I was a child. My abuse is still difficult for me to talk about, much less think about, but I think it is important for me to share with you how much Vlad helped me. Other victims involved in my lawsuit participated anonymously because their abuse still haunts them today, but I did speak to them, and they share the same gratitude, fondness, and appreciation for Vlad that I am sharing with you today. Importantly, they are in a much healthier state of mind today than they were before they met Vlad.

When I was young, I was a pretty vibrant girl, had an outgoing personality, and loved playing basketball and volleyball. I had many friends and dreams of playing college basketball. I trained all the time and was laser focused on reaching my goals. I made my high school varsity team as a sophomore which was a great accomplishment, but that was when I was sexually groomed and abused by one of my high school coaches, Dwayne Yuen. When I tried to speak up, he spread rumors about me and turned everyone against me. I won't get into the details here, but it was the worst experience in my life, completely ruined high school for me, made me a loner that had no real friends, and shattered my basketball dreams.

I went through life with this dark cloud hanging over my head and blamed myself for the terrible feeling I had in me. After learning that the statute of limitations had been extended for sexual abuse claims, I and others sought out Vlad because of his great reputation, and I had met him in the past and he has always been a nice and respectful person. It was not until Vlad helped me and other victims that we truly understood that what happened to us was not our fault because that inner turmoil and guilt never left us. We were just children that were taken advantage of by a person with power and authority over us and were manipulated into thinking that we were at fault for everything bad that happened to us. In our brains, we knew that it was not our fault, but something inside of us lingered that continued to perpetuate self-hate. Taking the leap to come out publicly and to confront my demons helped me to finally find closure to this terrible experience and I can proudly say today that I am a strong woman that can stand up for myself and take on all challenges with my chin high. I could not say that before.

Vlad was such an amazing attorney. I was so impressed with his ability to build the case, he worked so hard and never stopped until we reached our goals. He always treated us with dignity and respect and made us feel like strong, independent women that were taking over control of their lives. Vlad was instrumental for me in finding my true self and I can now say that I am truly happy with my life today thanks to his help.

Vlad is the perfect person to take on the job of an associate justice because he cares about people, he is so smart, and he fits the part in every way. I strongly support Vlad and hope he will be our next Hawaii Supreme Court Justice.

First, he attended the then Boalt Hall at the Berkeley campus of the University of California, a fine and respected law school in our country. Second, he is a very successful private practitioner. And, third, he is a man of integrity and character as demonstrated by his work while serving as the Chair of the State Land Use Commission. From my 52 years of practice, I would opine that the Governor does not have too many opportunities to select a candidate with these combined qualifications.

In addition, he represents "new blood" that the judiciary should welcome. As I understand, all other applicants are now serving as a judge in one capacity or another.

And, finally, he comes from "good stock." His father Paul who recently passed away, served as the Corporation Counsel and Managing Director of the City and County of Honolulu. His mother, now 95, is a Japanese national who was an accomplished concert pianist and studied at the world famous Juilliard School of Music in New York City where she met her husband who was studing law at Columbia.

- Meeting of the President, the Interim Executive Director, and the nominee prior to the scheduled interview of the nominee by the Board.
- Interview of the nominee by the HSBA Board.
- Deliberation of the HSBA Board.
- Submittal of the HSBA Board's recommendation to the confirming authority.

The HSBA President and the Interim Executive Director met with Mr. Devens on November 13, 2023, to discuss the subcommittee's findings. On November 14th, Mr. Devens was interviewed by the HSBA Board of Directors in executive session.

Documentation submitted by Mr. Devens was reviewed and the references listed were contacted for their personal opinions and observations. The comments and letters received from HSBA members reflected an affirmation of Mr. Devens in all categories of the HSBA criteria which include:

- Integrity
- Diligence
- Legal knowledge and ability
- Professional experience
- Temperament
- Financial responsibility
- Public service
- Ability to fulfill the responsibilities and duties of the position.

The Board of Directors of the HSBA met on Tuesday, November 14, 2023, to interview Mr. Devens. We recognize that since Mr. Devens has been a member of the Board and active in numerous HSBA activities, committees, and task forces, this process requires our careful attention to any conflict of interest. Mr. Devens was not at the meeting or involved in the Board's simultaneous review of Chief Judge Ginoza for an Associate Justice position. As is our process, members of the Board were polled as to any conflict of interest. Two members who had written letters of support for Mr. Devens were recused from decision-making.

After extensive dialogue and questioning with Mr. Devens, the Board found that he is **qualified** in each of the categories of the HSBA criteria to be an Associate Justice of the Hawaii Supreme Court.

Mr. Devens, after graduating from the University of California Berkeley Law School (then known as Boalt Hall), returned to Hawaii and has spent his entire legal career in Hawaii. Prior to entering private practice, Mr. Devens spent 6 years with the Honolulu Police Department, and continues to provide legal training and expertise for the HPD. After entering private practice, Mr. Devens has earned a reputation as a highly skilled litigator. He has taken on (and won) complex cases resulting in precedent case law. In addition to his extensive courtroom experience, Mr. Devens has served in multiple quasi-judicial roles, as Chair of the State Land Use Commission, as a member of the Board of the Office of Disciplinary Counsel, and as a Hearings Officer with that office. He has also participated in numerous mediations with Dispute Prevention Resolution, where he has either represented parties or served as the "third" (impartial) panel member.

Mr. Devens has devoted extensive time to public and private community service, teaching in multiple HSBA, Judiciary and WSRSL programs, participating in mock trial and advocacy programs,

and coaching in various youth activities. Although the appointment of a lawyer from private practice directly to the Supreme Court may appear unusual, it has happened many times in the past and has resulted in several esteemed jurists, including Chief Justice William S. Richardson, and most recently Associate Justice James Duffy.

It is not possible to list the breadth, variety, and depth of Mr. Devens' experience – all of which will add to the experience and diversity of the Hawaii Supreme Court.
