# TESTIMONY OF THOMAS D. FARRELL IN SUPPORT OF GM 2, NOMINATION OF BRIAN COSTA

Good Morning Senator Rhoads and Members of the Committee:

Thank you for the opportunity to comment on the nomination of Brian Costa to move up from Family Court to the Circuit Court. I strongly urge your favorable action.

I have known Brian Costa since he first became a per diem judge in family court. Prior to that, he had been a criminal defense lawyer, with particular expertise in impaired driving cases. With that background, the Bar wondered how he would do in family court, but we soon learned that he was a very quick study.

Like the nominees before you today, I have had many hearings and trials before Judge Costa. I remember in particular a very difficult child sex abuse case in which I represented the child's mother. Like the others, I didn't get everything I wanted from Judge Costa, but I felt his decisions were fair, reasonable, and supported by the law and the evidence. It was clear to me that he truly cared about the well-being of this child, and did not simply rubber-stamp whatever DHS wanted the court to do.

He is another that I can see coming back as the Senior Family Court judge. His experience in criminal law would also make him a good candidate for the other family circuit judge, who conducts jury trials in domestic abuse prosecutions.

In short, I believe that Judge Costa will do well on the Circuit Court, and hope that this committee will recommend that the Senate confirm his nomination.

The undersigned submits this letter in support of confirmation of Gubernatorial Nominee **Brian Costa** ("Brian") for appointment as a Judge to the First Circuit Court of the State of Hawaii.

I have been licensed to practice law in Hawaii since 1993, and my practice primarily involves the representation of condominium and community associations. A minority of my practice has historically also included representation of defendants in multi-party asbestos personal injury litigation, and defense of insurance agents in professional liability cases.

I have known Brian for approximately fifteen (15) years since he was elected to serve on the Board of Directors of one of this firm's condominium association clients. The undersigned has worked with hundreds of condominium association board members over the past 30 years, and these unpaid often very high-pressure positions require patience, discipline and analytical skills. When elected to the Board of this large high-rise condominium project, Brian was immediately presented with several management and operational challenges. Brian quickly assumed a leadership role on the Board and demonstrated remarkable skill in patiently working with and guiding his fellow Directors toward creative solutions which not only benefited the vast majority of owners and residents but avoided expensive and time-consuming litigation. The discipline and patience exhibited by Brian during his tenure on this condominium association board are also skills which have apparently served him well as a District Court Judge and will also continue to prove valuable as a Circuit Court Judge.

I have not appeared before Brian in his capacity as a District Court Judge, but we do socialize together on occasion. I have never observed Brian exhibit any disrespect toward others in a social setting, not any behavior which would be considered inappropriate for a Hawaii State Court Judge.

Based on my discussions with numerous attorneys who have practiced before Brian in District Court, Brian has a good reputation for honesty and integrity in the local legal community.

Comments: Testimony of Makia Minerbi, in support of the nomination of Brian Costa to serve as a Circuit Court Judge in the Circuit Court of the First Circuit. My name is Makia Minerbi. I have known Judge Brian Costa since he began sitting as a per diem judge in Family Court and have appeared before him countless times since his appointment as a fulltime judge. I have worked alongside him on the standing committee on Hawai'i Family Court Rules and the committee to revise the 587A Benchbook. I was admitted to the bar in 2008 and after clerking in Circuit Court (J. Michael Wilson) began practicing law with a focus on family law. I manage a staff of six attorneys and paralegals who provide legal services exclusively in the area of family law and coteach an experiential learning course (Family Law Clinic) at William S. Richardson School of Law each Spring. I give this testimony in my personal capacity. I have appeared before Judge Costa in Child Protective Act Cases (587A), Guardianships (560), Adoption (578), Divorces (580), and through the years, probably also Parentage (584) and Restraining/Protective Order (586) cases. A few years ago, my firm was appointed as Guardian Ad Litem in all the 587A cases set in his courtroom, so my colleagues and I appeared before him in hundreds of hearings. Thus, my view and opinion of Judge Costa is derived from many interactions and data points. I can say with confidence that Judge Costa is knowledgeable of the law, its nuances and current developments. As a judge, he has good temperament, runs court efficiently, and is always prepared. When I appear before him, I know the rulings on evidence will be precise, the correct law will be applied, each party will receive a fair hearing and be treated with respect, and the competing positions will be carefully weighed based on the admitted evidence. Very often, I agree with his rulings, but even when I do not their logic and fairness is still apparent. In running committee meetings Judge Costa is also collegial, focused, and effective. It is because Judge Costa is so diligent with procedural issues, evidence, and the law, that we continually invite him to preside over the Family Law Clinic students' mock trial, knowing that he will provide them an accurate simulation of the rigors of Family Court litigation in which to test their skills. I have practiced family law in Hawai'i for over 45 years. I first appeared before Judge Costa when he was starting out as a Per Diem Family Court Judge. I recall that he was well prepared for the hearing, having read the pleadings and was therefore able to ask intelligent questions of counsel. He was courteous to counsel while at the same time being in complete control of his courtroom. Since that initial hearing, I have appeared before Judge Costa on many occasions and served with him as a member of several family law committees. Judge Costa and I are currently members of the Hawai'i Family Court Rules Committee. The committee is tasked with a thorough review of the current family court rules for purposes of updating, revising and conforming the rules to changes in the law and practice. At the time, I presided as Managing Attorney of the Family Law Division at LASH and acted as the firm's liaison with the Court. Our guardian ad litem team of eight individuals appeared before Judge Costa on a regular basis.

- The Executive Director and I met with Judge Costa on June 19, 2024, to discuss the subcommittee's findings.
- On June 20, 2024, the HSBA Board of Directors interviewed Judge Costa in an executive session.
